Docket B15-03: Application of Peter Reichmann for a variance to Section 5.01 of the Borough zoning regulations so as to permit a 44' setback on the southerly side of the property for the building of a staircase attached to the front yard porch. The property is located at 18 Elm Drive, owned by Mary Andreotta and is in a R-1 Zone in the Borough of Newtown.

Vice Chairman Geckle opened the public hearing at 7:00 p.m. Mrs. Maher read the legal notice. Peter Reichmann, 7 Plumtrees Road, Newtown, presented the application on behalf of the owner, Mary Andreotta, who was also present at the hearing. Mr. Reichmann discussed the shape of the lot as being squarer where all the surrounding lots were more rectangular. He said that property has very little backyard and a large front yard. Ms. Andreotta stated that the only outdoor living space is the front porch. The variance is for the staircase.
