Minutes of the special meeting of the property owners and/or electors of the Borough of Newtown on Tuesday, May 10, 2016 at Edmond Town Hall in the Old Courtroom, for the purpose of voting on the proposed budget for the 2016-2017 fiscal year. Warden Gaston called the meeting to order at 8:39 p.m.

Absent: Senior Burgess Joan Crick, Treasurer Paula Brinkman, Zoning Officer Jean St. Jean

Also Present: LeReine Frampton, Registrar of Voters and 24 members of the public

Warden Gaston thanked everyone for attending the meeting and copies of the 2016-2017 proposed budget were distributed. He noted that the Mill Rate will remain almost the same and went through each line item individually. A new line item is Cultural Arts which will help support/sponsor events taking place in Newtown, particularly at Edmond Town Hall. Warden Gaston reminded everyone that if their property is within 100 feet of a fire hydrant, to be sure to look for a discount on their homeowner's insurance. The Garden Club which takes care of the islands in the Borough asked for help with the watering of the plants. Newtown Hook & Ladder offered their assistance and, in return, the Borough will provide them with a stipend. This year sidewalks will need to be resealed. The flagpole is now being maintained by the Borough so \$100.00 is allocated to that line item to cover costs.

Revenues Anticipated from Prior Year are \$7,000.00; Building Revenues Anticipated are \$10,000.00; and Interest is \$1,000.00 making total revenues other than taxes equal to \$18,000.00. The Tax Collection Rate is 98.0%. The Proposed Mill Rate for 2016-2017 is 0.86% which is slightly up from last year given the Grand List has gone down.

Warden Gaston asked if there were any questions. John Madzula, 58 Schoolhouse Hill Road, asked where the numbers for Land Use come from; he questioned why the Town and the Borough do not share in these expenses. Warden Gaston explained that the Borough is its own municipality and is required by Charter to have those positions in place. It is more cost effective to offer the Town a stipend for shared services rather than paying salaries for the positions on its own. Mr. Madzula also questioned how it was determined that the Sidewalk line item was spent. Second Senior Burgess Maher explained that each year they look at a different section of sidewalk that is in need of repair; the cost for a 200 foot section (removal and installation) is approximately \$15,000.00. There were 22 votes in favor of the budget and 2 opposed.

Attorney Donald Mitchell made a motion set the Borough's mill rate at 0.86%, seconded by Doug Nelson and unanimously approved.

Burgess Kenyon made a motion to adjourn the meeting at 7:57 p.m., Burgess Baiad seconded the motion and unanimously approved.
