CORRESPONDENCE AND ANNOUNCEMENTS – Mr. Dwyer announced the resignation of regular member Anna Wiedemann and extended the appreciation of the Commission for her many contributions to its work. He then welcomed JoAnne Albanesi who was recently appointed as an alternate member. He will be requesting that the Board of Selectmen change Joanne Davis's membership from alternate to regular to fill the vacancy left by Ms. Wiedemann's resignation because she is the longest serving alternate member. He pointed out, however, that in accordance with the Town Charter, the open position must be advertised in the *Bee* for a period of time and the BofS are free to appoint someone else. In view of this alternate members Imbro and Albanesi should notify the BofS if they wish to be appointed.

UNFINISHED BUSINESS

Senior Directory – Although the group assigned to creating a Senior Directory have not met recently they are working on an online/electronic copy for posting to a website.

Planned Giving Program – Mr. Symes pointed out that there was an article in last week's *Bee* about two recently deceased town residents who left \$2,000,000 to Newtown for use in operating the Town's new animal control facility and he hoped that others would be inclined to leave similar amounts to the COA's Gift Fund. He commented that when our Planned Giving Program is in place it will remind residents of the needs of our seniors so they'll make bequests to the Gift Fund in their wills. Finance Director Bob Tait, Town Attorney David Grogins and First Selectman Pat Llodra all support the concept and are involved. The National Council on Aging has some excellent educational information on this subject.

TREASURER'S REPORT (ATTACHMENT B TO THE ORIGINAL MINUTES) - Ms. Aurelia distributed a report of current balances in the Gift Fund but pointed out that after it was printed the Fund received a check for \$1,000 from the Lions Club which will be noted in next month's report.

At this time Mr. Schneider and Ms. Lydem left the meeting.

DIRECTOR OF SENIOR SERVICES REPORT (ATTACHMENT A TO THE ORIGINAL MINUTES) - Ms. Place distributed her report for the period April 17th to May 21st and after reviewing it with the commissioners asked that they note particularly her alternative proposals for obtaining additional revenue to pay for the classes she provides. One approach is to increase the annual dues for member-ship at the Senior Center from \$12 per person to \$24 per person; the other is to charge a fee for each class. She said that she favored the former but requested the commissioners to reflect on the matter and give their views at the next meeting. She also asked for a withdrawal of \$200 from the Gift Fund to pay for flowers to be placed in the front and back of the Senior Center which was unanimously approved.

MUNICIPAL AGENT FOR THE ELDERY REPORT (ATTACHMENT C TO THE ORIGINAL MINUTES) - Ms. Piccini distributed and went over her Report dated May 21, 2012.

NEW BUSINESS - None reported.






Advance Directives Workshop Keeps Seniors Informed

Junior/Senior Project Provides Intergenerational Fun

The idea for her junior/senior project s one that she carried away from a ummer spent in New Jersey with her randfather, Peter Flipse, nearly five ears ago, said Newtown High School unior Rachel DiVanno. The summer f 2007, Rachel painted a birdhouse uilt by her grandfather to the specifiations of one designed by famous 9th Century omithologist and natualist John James Audubon. They ere so pleased with the result that Ir Flipse made more birdhouses for us friends, and Rachel realized that his was a project she could keep in aind for her latter high school years. The self-directed junior/senior projcts allow students to explore intersts and make connections to the torld outside of the school, said

to planning and impleienting the project to take he place of a class that will arn her a half credit.

The first big step of her ohn Audubon Bird House roject took place under the entorship of her grandfaier the first days of spring acation this month.

"I had to learn to use a idial arm saw to build the rdhouses," said Rachel, a ol she had only seen her andfather operate before. sing white pine wood nated by Home Depot, achel carefully cut out and sembled 12 simple birdruses. Each birdhouse has a illed 14-inch hole, attracre to the bluebirds and arrows common to this rt of Connecticut.

The birdhouses have air nts and drainage holes to low waste to fall through.

realized that perches should not be on birdhouses," said Rachel, "because they only provide a place for predators to perch and get at the birds' eggs."

Rachel's project is about more than building and painting birdhouses, though. It is an intergenerational project that allows her to pursue her interest in connecting with senior citi-

"I met with Marilyn Place [Newtown Senior Center director to determine the size of the class and when we could do this, before we went to my grandpa's," said Rachel.

After completing the birdhouses, Rachel delivered them to the Newtown Senior Center, Thursday, April 19, where she oversaw a special workshop from 10:30 am to 1 pm. A dozen members of the Senior Center had signed up to paint the birdhouses, using paints supplied by the center and additional supplies purchased with a \$50 grant Rachel received from the Newtown High School PTA.

"It's sort of a passion of mine," said Rachel. "I'm very close to my grandpa, and when I visit him I spend a lot of time in his club with his friends. This project gives me a chance to do the same in my own community," she said.

On Thursday morning, Rachel introduced herself and her project to the seniors gathered in the workspace, and by 11 am the base coats of paint were applied and decorative touches were being applied. Rachel provided samples of birdhouses created and decorated by herself and her sister Jessica, as well as photographs of other painted birdhouses to serve as inspiration.

Rose Cipolla, a member of the New-

town Senior Center, eagerly dabbed bright pink paint on her birdhouse. "This is a new experience for me." exclaimed Ms Cipolla. "I heard about it and thought, why not? It's the first time I've ever painted," she said.

Seated across from Ms Cipolla, Beverly Panettiere carefully painted a starburst around the entrance hole to her birdhouse, and Bill Thiessen used precise strokes of the paintbrush to add designs to the birdhouse he was painting. Up and down the long worktable, painters focused on their projects, pausing to admire each other's work or to step back and assess what had been completed.

Rachel circled the room, offering advice and making suggestions for those who were less familiar with craft painting.

"I think it's important for creative

outlets to be encouraged, especially at older ages," said Rachel.

Hooks would be attached and the completed birdhouses would be left at the center to dry, after which Rachel planned to take them home and coat each with a protective coat of polyurethane.

Then I'll bring them back to the center, and they can take them home," said Rachel. The birdhouses can be used as an interior decoration, she said, but she hopes that most of them will be hung outdoors where they can provide shelter to wild birds. "People are sometimes afraid that the birdhouses will get ruined outside, but the polyurethane does protect them," Rachel said.

Looking around at the 12 Senior Center members painting diligently, Rachel said, "The energy here is great. I love it."

Director of Social Services/Municipal Agent For The Elderly Report for May 21, 2012

Energy Assistance is over. We are now doing applications thru Operation Fuel to help with an electric bill. Their income has to be below the 200% of the poverty guidelines. They also have to have a shut off notice.

The State of Ct., Office of Policy and Management has started the Rental Rebate Program for Totally Disabled and Elderly. I attended the training on May 9th and with the help of the IT Department we should be able to start soon.

On Saturday, May 12th I had the Postal Food Drive. The amount of food donated was good. I should have enough to keep food on the shelves till the holidays. I had eight seniors use the pantry today.

I am still seeing three seniors on a weekly basis. One woman who is blind, to check her mail and complete forms or pay bills. One senior will be getting homecare soon and she is agreeable to the person coming three times a week. The other senior is doing better on an Alzheimer's medication but will not let anyone in to help her. Thru the job bank I am hoping to get a person to cut their lawns each week.

I have two people I am helping with senior housing applications. They cannot afford to live in their homes after they spend their savings. Most of the senior housing sites take up to three years before they can move in. Bethel told me to call in three months for an application.

Both I and Noreen from the Area on Aging are trying to help a woman at Nunnawauk to clean her apartment and take a bath. Housings have to inspect the apartments once a year and this one failed. Her daughter has not come to get her and she was found on the floor not able to move. She did not want to go in the ambulance but with the help of Noreen at Nunnawauk she was taken and admitted.

I saw six elderly at their homes to complete Medicaid applications and seven with renewals for Medicare Savings Program. We have helped fifteen people this month with Medicare and the drug card. Several are looking for information because they are planning to retire soon.
