

Mr. Symes called the meeting of August 15, 2016 to order at 5:07pm.

Chairman's Report (Attached): Mr. Symes wanted to congratulate Ann LoBosco on receiving the title Director of Social Services, and Ms. Place is excited to welcome her into the office for a handful of hours a week. He then regretted to inform the Commission of the passing of Lesley Sharpe, wife of Bob Sharpe. The COA offers their condolences, and greatly appreciates all that the couple has done for the Senior Center.

Mr. Symes mentioned coming events (Newtown Cultural Arts Festival, Fairfield Hills Campus, September 17 and 18 and Health Fair, Reed Intermediate School, September 17, Friends of Newtown Seniors (FONS) & COA Senior Shredding Day, October 1). He said that local newspapers have been interested in reporting on the needs of seniors, and is hoping to use that as visibility for 2017 CIP New Senior Center funding awareness and publicity.

Minutes: With no changes, Ms. Bloom made a motion to accept the minutes of July 18, 2016. Ms. Imbro seconded, and the minutes were unanimously approved.

Public Participation: Karen Aurelia, 10 Cherry Street, was upset about being placed on an email list from FONS, and did not want any further correspondence. Discussion ensued about the relationship with FONS and the COA, and Ms. Torres thought it would be a good idea to foster more communication to the seniors to clarify the objectives/relationships between the groups. Mary Helen McCarthy, 3 Main Street, spoke to a previous topic of free COA giveaways at the Arts Festival by showing eye glasses cleaners with a printed logo. She also had new business cards which included contacts for the different Newtown Senior Functions to facilitate communication between the public and necessary groups. Stephen Rosenblatt, 50 Watkins Drive, felt that there should be no perceived competitiveness between COA and FONS, and wanted to provide the seniors with good information about the groups.

Discussion Items:

- 1. Ms. Wiedemann dispensed a revised version of the by-laws for members to review and discuss at the next meeting.
- 2. Mr. Symes explained the CIP funding as a multi-month adventure. The process for approval goes from the Board of Selectmen to the Board of Finance, then the Legislative Council. January of 2017 is the estimated time for final approvals. To his knowledge, there is still a 3 million dollar line item for the Senior Center.
- **3.** Ms. Bloom gave an update of FONS, agreeing with earlier discussion that they will work to get seniors and participating services in the same loop, possibly by doing info sessions at the Senior Center.
- **4.** Ms. Ryles said that the website funding is going better than expected, and they will be establishing an advisory committee between the partaking towns.
- **5.** Ms. Wiedemann distributed a financial report (attached).
- **6.** Ms. Place informed the Commission about recent technical issues that she has encountered, that will be fixed soon. She went over many of the events coming up, and was pleased to tell the COA about a projector and sound system that was being homed at the senior center. This will be available for use thanks to the Newtown Cultural Arts Commission. Ms. Place passed around a clipping from the Newtown Bee, with a picture captioned *Intergenerational Fun at Senior Center*. This is a program that began years ago, courtesy of Ms. Schmidle.

After some brief discussion about the importance of senior citizens in the community, and necessary changes moving forwards, the meeting came to a close.

Ms. Schmidle made a motion to send sentiments to Mr. Sharpe on behalf of the Commission. Mr. Guidera seconded. All were in favor and arrangements will be made.

Mr. Guidera made a motion to adjourn. Ms. Bloom seconded. All members were in favor and the meeting adjourned at 6:30pm.

Newtown Commission on Aging (COA) - Chairman Report - 8/15/16 Meeting

Welcome to our August COA Meeting and build-up to the celebration of National Senior Center Month in September. September will be a very important month not only for its National Senior Center recognition but more importantly on the local level for its timing in the reviews & recommendations process of the Newtown 2017 CIP Funding initiatives, specific to the long awaited & overdue (since 2003) New Senior Center.

If Newtown is to step-up to its role within the surrounding, regional communities in being recognized as a senior-friendly, Aging-in-Place town then a commitment to a New Senior Center with Expanded Senior Programs is paramount and effects all of our 5,000+ Seniors, age 60 and older.

As this past Sunday's Danbury News-Times, front-page article highlighted, the CT senior population is growing exponentially and surrounding towns need to invest in their seniors socialization and needs. It was pointed out, as the COA had determined back in the 2013-2014 Community Center analysis, that the majority of the local surrounding towns and beyond have already invested significantly in Senior Center Expansions.

In fact, just recently a local facility that has been following the saga of the New Newtown Senior Center for many years came forward with an attractive offer-proposal to host a new, customized Senior Center within their existing environment at Fairfield Hills.

Currently, the new Friends of Newtown Seniors (FONS) group sees a New Senior Center as critical to the success of future Senior Programs and a key facilitator for expanded Socialization, especially now with the new Community Center underway.
