Mr. Ryan opened the meeting at 7:00 pm.

# **Public Participation**

Linda Hess, 5 Cornfield Ridge Road, Newtown, spoke about metal stakes marking the Open Space (O.S.) easement starting on Castle Hill Road and ending at Old Castle Drive. Ms. Hess stated that the stakes pose a safety issue for people walking in the grassy area at night because they are not visible. Ms. Hess also stated that the stakes are "ugly". Ms. Hess recommended having better signage for the O.S. easement. Mr. Boland will drive by the O.S. area and report back to Commissioners at the next meeting. Mr. Sibley will be notified of Ms. Hess's concerns.

## Approval of Minutes for April 11, 2016

Mr. Ryan requested a motion to approve the minutes from April 11, 2016. Mr. Philbrick so moved. Ms. Joyce seconded. All if favor.

#### **Action Items**

Mr. Boland spoke to the Commission about his meeting with Cleo Conk on Earth Day. Ms. Conk specializes in birds and would like to do a bird survey at High Meadow. The Commission agreed that would be a great study. Mr. Boland will reach out to her.

<u>Sandy Hook Permanent Memorial Commission (SHPMC)</u>: The Commission questioned why the SHPMC hasn't invited the Conservation Commission on any site walks. Mr. Ryan stated that he and Mr. Lyddy have been in contact and Mr. Ryan will reach out to Mr. Lyddy regarding site walks. Ms. Sturmer also noted that the Parks and Rec Chairman was invited to a SHPMC site walk and Parks and Rec has been involved in the process.

Mr. Ryan asked the Commission if they would be interested in inviting Gary Sorge to a CC meeting. Mr. Ryan felt this would be a way to be involved in the SHPMC process. The majority of the Commission agreed to invite Mr. Sorge to a CC meeting. Mr. Ryan will reach out to Mr. Sorge.

<u>Planning and Zoning</u>: Ms. Joyce reviewed the Planning and Zoning minutes and stated that there were no issues affecting O.S.

<u>Parks and Rec</u>: Ms. Sturmer spoke about the Fruit Tree Trail and will follow up at the next meeting.

<u>Inland Wetlands:</u> Mr. Boland spoke about an Iroquois project that was approved by the Inland Wetland Commission.

On a separate note, Mr. Boland also mentioned that the Iroquois grant application was submitted prior to the deadline on May 1, 2016. If the Iroquois grant is awarded to the CC the funds will be allocated to the Stone Bridge forestry project. The Commission will reach out to Jeremy Clark of Clark Forestry Services to start the process.
