Public Participation: Lori Walker of the 12/14 Foundation meet with the EDC of July 14, 2015 to discuss the possibility of renovating Plymouth Hall on the Fairfield Hills campus as a performing arts center. Dr. Michael Baroody, MD created the non-profit foundation in response to Sandy Hook Elementary School tragedy. This foundation is having a great response from kids and their parent; they need a home to expand the program to make it a year round program. The 12/14 needs to have more clarification about renovation and costs before making any kind of commitment. The EDC supports a performing arts center on the Fairfield Hill Campus in hopes the space would allow for local businesses to use it as well for conferences, business needs, etc. It would also act as an economic driver for the campus to increase interest for a restaurant on the campus in the future.
