#### **COMMUNICATIONS:**

MINUTES – Mr. Goden moved to approve the minutes of the 5/11/15 meeting as presented. Mr. Waterbury seconded, motion unanimously approved.

FIRST SELECTMANS REPORT – Mrs. Llodra announced that the new Community Center Commission has appointed co-chairs Andy Clure and Brian Hartgraves. More research was done regarding prevailing wage for the Hook & Ladder project. A project was done by Weston fire fighters that mirror what is being done in Newtown and they did not pay prevailing wage. There is precedence and that was settled in 2009. On June 28 from 2pm to 4pm there will be a celebration for Mae Schmidle and Julia Wasserman at Congregational Church. June 3, is an open hearing for FOI. Sandy Hook School project is moving along. Senate bill 593 which is the marriage of the cancer bill for firefighters and the mental mental bill recognizing PTSD has passed the senate and it is unlikely that the house will take it up which is good news for Newtown in regards to cost Sandy Hook Lobster fest is June 5 & 6 and Hawleyville is creating their own fundraising event which is on June 13. Mrs. Llodra pointed them out because there is pressure for them to raise money. Relay for Life is June 13.

**FINANCE DIRECTOR REPORT** – State auditors were here auditing the victims fund. It went well and they did not request any additional information other than what was requested for their audit. They will be back in another year.

Mr. Godin moved to add the CIP calendar to the agenda. Mr. Waterbury seconded, motion unanimously approved.

Mr. Waterbury moved to accept the CIP calendar as presented (Attachment A), Mr. Portnoy seconded, motion unanimously approved.

Mr. Waterbury moved the RESOLUTION PROVIDING FOR A SPECIAL APPROPRIATION IN THE AMOUNT OF \$300,000 FOR THE PLANNING, DESIGN, AND CONSTRUCTION OF RENOVATIONS AND IMPROVEMENTS TO THE CYRENIUS H. BOOTH LIBRARY AS AUTHORIZED IN THE CAPITAL IMPROVEMENT PLAN (2015-16 to 2019-20) AND AUTHORIZING THE ISSUANCE OF \$300,000 BONDS OF THE TOWN TO MEET SAID SPECIAL APPROPRIATION AND PENDING THE ISSUANCE THEREOF THE MAKING OF TEMPORARY BORROWINGS FOR SUCH PURPOSE and waved the reading of the full resolution. Mr. Portnoy seconded, motion unanimously approved by a roll call vote.

Mr. Godin moved a RESOLUTION PROVIDING FOR A SPECIAL APPROPRIATION IN THE AMOUNT OF \$300,000 FOR THE PLANNING, DESIGN, AND CONSTRUCTION OF IMPROVEMENTS TO THE EDMOND TOWN HALL BUILDING AS AUTHORIZED IN THE CAPITAL IMPROVEMENT PLAN (2015-16 to 2019-20) AND AUTHORIZING THE ISSUANCE OF \$300,000 BONDS OF THE TOWN TO MEET SAID SPECIAL APPROPRIATION AND PENDING THE ISSUANCE THEREOF THE MAKING OF TEMPORARY BORROWINGS FOR SUCH PURPOSE and waving the full reading of the resolution. Mr. Waterbury seconded, motion unanimously approved by roll call vote.

Mr. Godin moved the RESOLUTION PROVIDING FOR A SPECIAL APPROPRIATION IN THE AMOUNT OF \$1,000,000 FOR PLANNING, DESIGN, CONSTRUCTION, RECONSTRUCTION AND IMPROVEMENTS OF VARIOUS TOWN ROADS AS AUTHORIZED IN THE CAPITAL IMPROVEMENT PLAN (2015-16 to 2019-2020) AND AUTHORIZING THE ISSUANCE OF \$1,000,000 BONDS OF THE TOWN TO MEET SAID SPECIAL APPROPRIATION AND PENDING THE ISSUANCE THEREOF THE MAKING OF TEMPORARY BORROWINGS FOR SUCH PURPOSE and waved the full reading of the resolution. Mr. Waterbury seconded, motion unanimously approved by roll call vote.

Mr. Godin moved the RESOLUTION PROVIDING FOR A SPECIAL APPROPRIATION IN THE AMOUNT OF \$3,600,000 FOR THE PLANNING, DESIGN AND CONSTRUCTION OF IMPROVEMENTS TO THE NEWTOWN HIGH SCHOOL AUDITORIUM AS AUTHORIZED IN THE CAPITAL IMPROVEMENT PLAN (2015-16 to 2019-2020) AND AUTHORIZING THE ISSUANCE OF \$3,600,000 BONDS OF THE TOWN TO MEET SAID SPECIAL APPROPRIATION AND PENDING THE ISSUANCE THEREOF THE MAKING OF TEMPORARY BORROWINGS FOR SUCH PURPOSE and waved the full reading of the resolution. Mr. Waterbury seconded. Kathy Hamilton for the BOE gave an estimate from Kaestle Boos (Attachment B). The document shows what the estimated amount that the state will pay which could be between \$500,000 to \$800,000. The project takes into account ADA requirements. Mrs. Llodra requested that she get something from the BOE for the BOS so they can do an 8-24 and assign it to the Building and Sight Commission. This is one of the first projects that should follow the newly implemented plan which would require official request and assignment.

Mr. Portnoy moved the RESOLUTION PROVIDING FOR A SPECIAL APPROPRIATION IN THE AMOUNT OF \$315,000 FOR THE PLANNING, DESIGN, ENGINEERING, CONSTRUCTION AND RECONSTRUCTION OF BRIDGE IMPROVEMENTS AS AUTHORIZED IN THE CAPITAL IMPROVEMENT PLAN (2015-16 to 2019-20) AND AUTHORIZING THE ISSUANCE OF \$315,000 BONDS OF THE TOWN TO MEET SAID SPECIAL APPROPRIATION AND PENDING THE ISSUANCE THEREOF THE MAKING OF TEMPORARY BORROWINGS FOR SUCH PURPOSE and waved the reading of the full resolution. Mr. Waterbury seconded, motion unanimously approved by roll call vote.

Mr. Godin moved a transfer - \$35,480 from Capital (1-101-13-650-5749-000) to Repairs & Maintenance Services (1-101-13-500-5430-0000) \$30,000 and Contractual Services (1-101-13-650-5505-0000) \$5,480. Mr. Waterbury seconded, motion unanimously approved.

**ANNOUNCEMENTS** – Mr. Kortze will forward an electronic copy of the Blum Shapro regarding municipal efficiencies. The LC has established their committee and John Godin and John Kortze will handle it for the BOF.
