## Committee Reports

Budget – Burton stated that the town-side of the budget has passed.

#### Truck – Jossick reported:

- Backordered Marshal's truck parts have arrived and will be installed this week. Expect delivery next week on or before May 30<sup>th</sup>.
- Engine #441 was involved in a minor two vehicle accident in a non-emergency trip for fuel. There were no
  injuries.
  - Kevin Stoyak, the driver, was sent to Corporate Health, per insurance policy, for a post-accident screening and had him fill out the required paperwork for the town.
  - He was given a written warning for failure to obey a traffic signal.
  - The damage is mostly cosmetic, but the alignment and frame are being checked for any unforeseen damage.
  - Firematic inspected the truck and suggested keeping it in service.
  - Repair costs are estimated to be \$2,585.59 and will be submitted through insurance.
  - o Repairs are scheduled for June 1, 2013.

MOTION: Burton made a motion to install a 108 Harness in the new Fire Marshal's vehicle.

#### Policies and Procedures - Goosman reported:

- The committee met and reviewed the Tax Abatement Program.

  - Not recommending a change in minimum number of annual calls
  - Recommend removal of section 208-20. Eligibility B #4 support members, per Company or Association bylaws.
  - Change Commissioner to Fire Commissioner.
  - Members will be going back to the individual fire departments for future discussion by the BOFC.

#### Purchasing – Burton reported:

- Finance department announced a new accounting system for the entire town July 2013
- Accounting System training will take place the last week of June Burton not taking time off from work to attend.
- Training balances: NHL \$3K; SH \$5.2K; United Fire \$2.1K; Hawleyville \$990 and Dodgingtown \$650.
- The Shipman Air Pak Flow Testing is scheduled
- Firefighter's Equipment has a balance will use for equipment repairs chief's to prepare a list of items that need repair.

  - Everyone on this committee needs to complete the State Tanker Shuttle Operating Course.
