### Committee Reports

## Chief's Meeting

- Halstead reported that on 9/30 a meeting was held with the chiefs who met with Mike Collins, EMS Chief, regarding number of tones going out. He will investigate why four tones are going out. Halstead also stated the fire departments will provide lift assistance if the ambulance services are short on staff to respond.
- Discussed the Labor Day parade and the Chief's would like to recommend an Emergency Services Division. Each department would bring only two vehicles. This would assure there was town emergency services coverage during the parade.
- New Tanker:
  - Custom chassis is most favored.
  - Where would the extra cost for the chassis come from?
  - Chiefs would like to know more details of what comes with the chassis.
  - Not sure if we need high, side compartments on driver's side.
  - Once answers are received the Chiefs can vote on it.
- Dodgingtown investigating hosting town-wide officers training for all five companies.
- Hawleyville holding hazmat tech class. No date set as of yet.

# Truck:

- Jossick reported that the transmission service was completed for NH&L and Hawleyville trucks.
- #339 needs a shift cable.
- DOT and Pump tests will start the first week in November.

## Budget:

- Nezvesky distributed budget timetable and asked departments to begin working on their budgets.
- Dodgingtown requested a few changes on their capital items. Dollar amounts stay the same. This was determined to be okay.

Motion: Goosman made a motion to recommend to Robert Tait, Finance Director, that he award the bid for concrete floor refinishing at Botsford Fire and Rescue to Scholar Painting and Restoration in the amount of \$17,820.00. Seconded: Bolmer Motion passed unanimously

### Old Business:

#### Tanker Truck Committee Report:

Matt Dobson asked that the BOFC give the Committee permission to continue working on the tanker custom chassis specifications, and then allow the bidding process to begin. This will assist them in determining costs. A custom chassis would have more safety features than a commercial chassis.

Manna commended the Committee on the amount of time and effort put into this initiative.

Motion: Jossick moved that the custom tanker go out to bid after developing specifications. Seconded: Bolmer Ayes – Whelan, Jossick, Manna, Goosman and Bolmer Nay – Nezvesky Motion passed
