Ms. Curran opened the meeting at 7:31 p.m.

PENDING APPLICATIONS

IW #15-01 149 Mount Pleasant Road, Walter Kilcourse. Construct building and associated site improvements.

Mr. Mark Kornhaas, Artel Engineering Group, LLC, Brookfield, CT, and Mr. James M. McManus, JMM Wetland Consulting Services, LLC, Newtown, CT, represented the applicant, Mr. Walter Kilcourse.

Mr. Kornhaas presented a stabilization plan which involves:

- Building a temporary crossing to access stream.
- Removal of old pipe
- Add necessary fill
- Repair, define and stabilize stream bank using coir logs
- Stream bank planting.

Mr. McManus first visited the site in July 2014. He returned to the site on July 2015. He presented aerial views dating back to 1934. Mr. McManus stated that the site has been repeatedly impacted over the years by developers which lead to diminished wetland quality. He stated that the current proposed plan will have no adverse impact on the stream and instead will be a total restoration of the existing stream.

The proposed parking lot will be in the front of the building away from the stream. There will be an 8 foot wall protecting the stream from the building and the parking lot.

The Commissioners needed more time to review the newly submitted plans and will make a decision at the next Inland Wetland meeting on September 9, 2015.
