Charter Revision:

Chapter 8: Mr. Capeci stated the Commission removed much of the language from the draft of Chapter 8, leaving it to the Legislative Council to write an ordinance to detail the specifics of Acquisition and Disposition of Real Property. There is language in the proposed Charter requiring the Council to initiate the process of creating the ordinance. Ms. Jacob asked why the commission is detailing the council create an ordinance for this section. Mr. Long stated people from land use said there was confusion regarding the process. Mr. Merola is not sure there should be a time limit for creating the ordinance, rather just to initiate the process. Mr. Burns noted these are one shot deals; if an error is made it cannot be corrected. Mr. Lundquist stated the language is unnecessary unless there are concerns an ordinance would not be created.

The Charter Revision Commission approved the updated version of Chapter 8 to be contained in the final document. Attached.
