

**LAKE LILLINONAH AUTHORITY REGULAR MEETING**

**CALL TO ORDER:** Chairman G. Petriccione began the meeting at 7:30pm.

Dr. Jen Klug, Biology Department, Fairfield University gave a presentation on, “The Dock and Buoy Programs – 2013 updates.” Items presented for the Dock Program included; goals of both programs, historical perspective – total phosphorus and total nitrogen, algal toxins, common bloom-forming cyanobacteria. Topics discussed for the Buoy Program were; what data are collected, thermal structure driven by river flow and air temperature, frequency and duration of hypoxia in Lake Lillinonah bottom waters, and secchi depth.

John Morrison, USGS gave a presentation on Lake Lillinonah Water Quality and Velocity Profiling – Summer 2013. Also discussed was; phosphorus cycling in lakes, how nutrients are cycled in Lake Lillinonah, Ecomapper 2013, and upcoming related projects.

Chairman G. Petriccione introduced Doug Vane, as Brookfield representative for the Lake Lillinonah Authority.
