OFFICER REPORTS:

CHAIRMAN'S REPORT:

Chairman G. Petriccione reminded the Authority that the Fourth of July fireworks are slated for Saturday and patrol coverage is set. Chairman G. Petriccione stated that he sent an email to First Light regarding water levels for July 4th. Chairman G. Petriccione stated that one of the AED's are no longer serviceable and is out of date. He also stated that he recommends purchasing a refurbished AED with all new updates for \$700.00.

A motion was made by S. Ward, seconded by W. Pelletreau, to authorize the purchase of a refurbished AED in the amount of \$700.00. Motion passed unanimously.

<u>FIRST VICE CHAIRMAN'S REPORT</u>: First Vice Chairman S. Young gave the Marine Patrol Boating & Safety Report for the month of June 2014. He stated that the water level was extremely high on Father's Day weekend – 198.3 NGVD. He also stated that he sent First Light photos of debris with facts, date, time, location, priority zone and what the lake level is at that moment. First

Light has not responded. First Vice Chairman S. Young discussed the boating accident by the Bleachery Dam. The boater was assisted by a fellow boater and Water Witch was dispatched.

TREASURER'S REPORT: Treasurer L. Leaden stated that she finally received the police report regarding the boating accident in 2013. She also stated that the going forward the audit will be bi-annual.
