Approval of Minutes- July 10, 2014 approved (M-Martin, 2-Krauss all approved)

Moment of Silence Sept 11th- Howard Lasher could not make tonight's meeting. Kyle will be meeting with him next week regarding a Memorial.

Public Participation:

Art Teacher Leslie Gunn and 6th Grader Ben Paley gave presentation on a proposed Memorial for the Town. Ben was a second grader on 12/14. He came up with this vision 2 days after 12/14. At that time he went to Miss Gunn and told her he wants to build a better world. He presented his blue prints which show the many elements he has envisioned for the memorial. It would have many things like a dove that represents life, a reflecting pool with Koi fish, hands, a globe, etc but each element has a very special meaning. He also used words like Harmony, peace, family, caring and strength to describe feelings he wants to reflect with his memorial. Commission thanked them for coming and told Ben it was a great Memorial and explained our process of research gathering. Scarlett Lewis told him she thought it was beautiful and she was touched by his presentation.

Lisa Barrett with Touched by Art and Jeff Duncan of Duncan garden & landscaping gave an update on her Sandy Hook Memorial Fountain. The base is cut and holes drilled for the lights/water. It has been delivered to O & G in Waterbury and the benches cut as well. Jeff will do permits and maintain fountain for life if accepted. Commission thanked her for the update and told her we are still in the research gathering phase but will keep her updated.

Richard Jones would like to be put on the agenda for the next meeting. He would like to do his presentation of a large Aerial park on a peace sign. We will add him to November agenda.

Kyle stated the Commission has been very busy setting up meeting and sub committees all summer and the next few months we will be working on the next Phases.

- Question 15 change the word "public" to "highly visible"
- Question 30 Change Newtown Borough to Newtown, remove Fairfield Hills and have box for Specific location within the Town of Newtown. This way they can write in their ideas.
