Public Participation: Rhonda Collins from Sandy Hook asked the Commission a couple questions on whether it will be indoor or outdoor and benches that were donated to the Town. Kyle explained it is an ongoing process and that we are looking at sites now that the weather is nicer. We will also meet with the families and discuss what has been gathered to date. He went over the sites they have looked at up to date like the Dayton Street area, ETH back lot, SAC field and other sites. Kyle discussed the ongoing presentations and whether we should continue if we will be doing an anonymous competition. Is a competition the right way to go? Do we keep anonymous to find the right person. One con is length of time. Kyle also gave and went over the 9/11 Memorial Competition Guidelines. Design Concept Submission vs Competition.
