For the month of February 2010 the agency had a loss of (\$7,186) and for the eight month period July 2009 through February 2010 we show a loss of (\$3,727). We continue to show a favorable outcome as compared to the budget loss of (\$5,828) and a very favorable outcome as compared to last years eight month loss of (\$88,714).

Income Year to Date - Compared to Budget under \$33,867

- Contributed support is ahead of budget by \$7,077
