The Board of Selectmen held a regular meeting Monday, November 7, 2011 in the Council Chamber of the Municipal Center, 3 Primrose Street, Newtown. First Selectman Llodra called the meeting to order at 7:30pm.

PRESENT: First Selectman Llodra, Selectman William F.L. Rodgers, Selectman William F. Furrier

ALSO PRESENT: Three members of the public and three members of the press.

**VOTER PARTICIPATION:** Barbara O'Connor, Little Brook Road said that the power company comes each year to trim and wouldn't take down an old tree at her request because there wouldn't be anything to trim next year.

Ruby Johnson, 16 Chestnut Hill Road thanked the board for their leadership over the past two years. Ms. Johnson also questioned the authority of P&Z based on a letter to the Bee from P&Z Chair Lilla Dean. Mr. Rodgers believed Ms. Dean was attempting to allude to the fact that only P&Z can zone Fairfield Hills. While it may be true only P&Z can make a zoning designation it doesn't mean that other governmental bodies have no say whether that use can actually go forward in a specific context. First Selectman Llodra said that the general statement cannot be applied to municipally owned land the same way you apply it to privately owned land. Ms. Johnson voiced concern about the POCD, the CIP and the band shell. First Selectman Llodra explained that the CIP has been forwarded onto the Board of Finance and is not finally approved until it goes to the Legislative Council. First Selectman Llodra said there has been discussion relative to the band shell because it is something that Representative Lyddy is trying to get state funding for.

ACCEPTANCE OF THE MINUTES: Selectman Furrier moved to accept the minutes of the regular meeting of October 17, 2011. Selectman Rodgers seconded and asked that it be added that the Tick Bourne Disease Action Committee report was well received by the entire Board of Selectmen who all commented positively about it. 
