The Board of Selectmen held a regular meeting Monday, October 5, 2015 in the Council Chamber of the Municipal Center, 3 Primrose Street, Newtown. First Selectman Llodra called the meeting to order at 7:30pm.

PRESENT: First Selectman Llodra, Selectman William F.L. Rodgers, Selectman James O. Gaston, Sr.

ALSO PRESENT: Finance Director Robert Tait, Lisa Schwartz-Poet Laureate

**POET LAUREATE:** Mrs. Llodra stated it was recommended by colleagues in the state that we consider a Poet Laureate. The Cultural Arts Commission established the process and conducted extensive interviews. The Poet Laureate is an ambassador for the Arts. Mrs. Schwartz prepared an Inaugural piece for the Cultural Arts Fair. Mrs. Schwartz stated we are the 9<sup>th</sup> town in Connecticut to adopt a Poet Laureate, a tribute to our town's sentiments toward the arts. *Attachment*

**ACCEPTANCE OF THE MINUTES:** SELECTMAN RODGERS MOTIONED TO APPROVE THE MINUTES FROM THE 9/21/15 AS PRESENTED. SECOND BY SELECTMAN GASTON. APPROVED.

### **FINANCE DIRECTORS REPORT:**

Recent State Budget Actions: Mr. Tait presented his report including a list of rescissions made to address decreased revenue. Mr. Rodgers noted the Department of Veteran's Affairs is a pass through; it receives money from the VA which is taken by the state and partially returned to the Department, the reason the cut to the Department of Veterans Affairs is only \$50,594. Mr. Tait noted the Municipal Opportunities and Regional Efficiencies program reduced the budget state budget by20 million. The state, presuming municipalities would save 20 million in efficiencies, reduced municipal aid. Selectman Llodra explained when the MORE commission was created several years ago, the goal was to find efficiencies that would generate savings. The MORE commission stated it has not found those savings. Municipalities don't have the will to do the big things that could save money, such as consolidation of dispatch. The state will still cut 20 million this year (2016) and another 20 million next year (2017). Basically, any municipal savings is being transferred to the state. Attachment

**Debt Analysis Report:** Mr. Tait presented his Debt Analysis Report for the past 20 years. Currently our debt is down to 9% of the budget. The Council wanted to see what an 8% debt cap would look like and when it could be realized. The key to investing in capital projects is the growth of our grand list. CIP, long-term planning is now part of our financial statement (page 7). In the current Annual Debt Service chart, the area between the red and blue lines represents the capacity for capital investment in Newtown. The Annual Debt Service (page 30) is the annual payment for all debt. Debt load is the total debt. Mr. Tait noted our rate of amortization is better than 50% in 10 years (page 33)

### **UNFINISHED BUSINESS**

**Update on CIP:** Mr. Tait shared the CIP. Selectman Llodra stated the recommended CIP was passed to the Board of Finance. She noted in year 5 a group of \*\* represents information that came in that night from the Municipal Strategic Planning Commission. They recommended setting aside money for work on the Multi-purpose building (\$814,000) and to demolish Hook & Ladder. They have only heard the report, they have not taken action. There are many moving parts on the CIP and questions that need to be answered. Hoping to have more info and move the CIP forward by the end of November. They are trying to keep options open until the Board of Ed has finished their work. *Attachment*
