

THESE MINUTES ARE SUBJECT TO APPROVAL BY THE WATER AND SEWER AUTHORITY

The Water and Sewer Authority held a regular meeting on August 14, 2014 at the Waste Water Treatment Plant, 24 Commerce Road, Newtown, CT. Chairman Brown called the meeting to order at 7:02pm.

Present: Dick Zang, Lou Carbone, Marianne Brown, George Hill, Alan Shepard, Gene Vetrano

Absent: Carl Zencey

Also Present: Director of Public Works Fred Hurley, Jason O'Brien and Julio Segarra of United Water Environmental Service, Attorney Robert Hall, Jay Patel and Chan Patel

Public Participation - None

Approval of Minutes – The previously distributed minutes of the regular meeting of 7/10/14 were unanimously approved.

UNFINISHED BUSINESS

Establish a Hawleyville Sewer District – This will be handled after the extension is completed. It will be individual properties not boundaries. If you are a property owner and the properties on either side of you are on the sewer, to become sewered it would be considered an extension.

FY 15 Budget – There is no material change from the last meeting. They are still getting the financial system up and running which should be ready for the next meeting.

Increasing Sewer and Water usage fees- The September 17th Legislative Council meeting will take up the water rates. Gene Vetrano moved to increase the primary sewer rate effective July 1, 2014 from \$7.79 to \$8.34 with a general administrative increase of 7% to all other rates. Motion passed with one abstainention, (Shepard).

Application of Newtown Mobil for discharge from a car wash – Attorney Robert Hall presented for the owners of Newtown Mobil (Attachment A). They are looking for approval to present to the Planning and Zoning Commission. The schematic that was provided in the hand out from Attorney Hall is what the state said that the WSA should accept as a minimum. This was verified by Fred Hurley's contact with state of CT DEEP permitting. This type of system will meet their requirement for industrial discharge. Alan Shepard moved to conceptually approve the application from Mobil Station at 62 Church Hill Road, for a car wash, with the conditions that they submit the manufacturer's specifications

on the grit and oil separators with the recommended pumping schedules. They also have to submit the pumping reports to the WSA for the disposals based on those pumping schedules. Dick Zang seconded motion unanimously accepted.

NEW BUSINESS

Committee Reports: SCADA, solar, I&I, Finance, regulations, water supply, collection and distribution systems—SCADA—installed a new DO, GHD will start working next week for tying in the sewer system and the programmers will come in on the 25th for the water. Once the water is running, they will go back to debugging the system as a whole. SOLAR—The solar panels have been working and there are no trips. I&I—still gathering data

Report by United Water Environmental Services Inc. – (Attachment B). There may be a problem with the Ambulance Garage. The clerk of the works has been informed that they put in 110V pump and they should have installed a 240V model. According to the manufacture, there are no 110V units in the state of CT. Various options will be explored including the requirement for them to pay for an additional unit as a backup.

Report by Public Works Director – The trailer park has individual septic systems for each pad. Putting in an internal gravity collection system may be the way to go. Marianne Brown said that they have an obligation as a board to prevent the inevitable. The added cost for this will be taken out of the individual benefit assessment or paid for by the grant. There will be a sit down with the property owner to explain the options and necessary actions to make the project feasible. Alan Shepard made motion to authorize Fuss & O'Neill to do a preliminary sketch with the caveat that the trailer park must provide Fuss & O'Neil with all the information needed to do the sketch at a maximum cost of \$10,000, Gene Vetrano seconded, motion unanimously approved.

Having no further business, meeting was adjourned at 8:43pm

Re: Mobil Station Application for Car Wash

Gentlemen:

I expect to appear at your meeting on August 14th where I am hoping you will approve the car wash application so that I can apply to the Connecticut DEEP under the General Permit procedures.

At your last meeting Julio Segarra spoke about "conductivity." What he may not have realized is that the effluent from the car wash is first mixed in a 1000 gallon tank before it is discharged to the sanitary sewer. By the time you get this letter I hope to have spoken with him and that we can reach agreement on the nature of the effluent as not being harmful.

I previously gave you the pH factor for the five chemicals used in the car wash but I told you I did not have knowledge on the exact quantities of each.

I have now received the information from the manufacturer of the car wash. The minimum amount of water used is 40 gallons per wash. The amount of detergent/rinse used with a low pH is 1.5 ounces and the amount of the detergent/rinse used which is a high pH is 2.5 ounces. 1.5 ounces neutralize each other leaving 1 ounce of high pH to be diluted in 40 gallons of water.

The math on that works out to be 40 gallons of water equals 5,120 ounces which creates a dilution factor of .078125 percent or 78 one hundred thousandths concentration.

MONTHLY OPERATING REPORT July 2014 TOWN OF NEWTOWN WPCF

EXECUTIVE SUMMARY

During the month of July the plant process performed well. Nitrogen average pound per day during the month was 10 lbs. The open channel flow meters have been relocated to new locations. The meters are located at a cross lot manhole on Taunton lake dr. coming from Diamond Dr. and directly prior to the Taunton Lake pump station. This will be our next areas of focus.

The plan will be to inspect during heavy rains for signs of inflow.

SCADA project is progressing through the pump stations

Pump stations have been completed for the most part with touch up work needed at all locations. Water Pollution plant also requires some minor touch-up and testing. There have been no operational events due to the upgrade work being performed. The DEEP has been kept in the loop as the project proceeds. The seasonal operation of Ultraviolet disinfection and Phosphorous removal have been operating well

Below are some of the highlighted major operation and maintenance items that are currently in progress or completed.

- Work being done on the Clarifier Building for the SCADA Project.
- The pump station upgrades were delayed to allow GHD to allow planning and installation of the plant SCADA System prior to disinfection season.
- The water pollution plant now has its own frequency using the Store and Forward method of communication.
- The store and forward will allow more frequent reports of data (every ten minutes or change of status) from each of the remote sites. Therefore improved resolution in the data!
- Knapp engineering will be submitting the final electrical drawings to GHD.
