Ray Hoesten, Chairman, called the meeting to order at 7:00 p.m.

Secretary's Report:

A motion to accept minutes as read from October1, 2013 meeting was made by Bob Mouchantat (seconded by Bob Sauve) and approved unanimously.

Public Comments:

Anthony D'Angelo,Newtown stated that the weed treatment was excellent, thanked Ray Hoesten,Chairman for checking the zebra mussels with him and will provide Ray with suggested LZA Bylaws changes.

Ray Hoesten reported that Dick Wagner will attend the Dec. LZA meeting to discuss zebra mussels and their DNA.

Water Quality / Grants Report:

Gary Fillion, Vice Chairman reported that he and Ray Hoesten will attend the First Light Meeting tomorrow night re:milfoil, zebra mussels and the emergency plan and report at the Dec. meeting; the zebra mussel committee is discussing the feasibility of treating Laurel Lake with CO2 to kill the zebra mussels. Gary will discuss the Lake Zoar debris locations and need for removal with Brian Woods; he reported that Thursday, November 7th, he and Ray will take DEEP reps on a boat trip to verify buoy locations and add two additional areas i.e. the old bridge abutment near the steel bridge.

Boats and Motors Report:
