### **Marine Patrol Report:**

Sgt.Dan Semosky,SP,reported that many infractions were noted and many repeat offenders were cited re: no ct.numbers on boats,going beyond warning sign at Shepaug Dam,etc.Monroe P.D. covered last weekend :two Boats were used on Sat 7/2<sup>nd</sup> and Mon 7/4<sup>th</sup> ,one boat on Sun 7/3<sup>rd</sup>;Fathers Day one Boat was used for extended hours.Terry Bogue,LZA Driver, reported that the overhead lights on the Boats have clouded polycarbonated lenses ,which greatly impair visibility.Sgt Dan Semosky,SP and Dick Speer will check replacements and cost prices.Sgt Dan Semosky S.P. will demonstrate the S.P patrol.car overhead lights to the Commissioners after tonight's meeting.

**Publicity/ Public Awareness:**

Ed Kusinski inquired re the status of the LZA Website paperwork which was sent to the Company; Gary Fillion will verify with Ray Hoesten, Chairman. Ed Kusinski reported that a Lake Zoar user requested a Lake Zoar Map which Gary Fillion provided and Ed will distribute.

**Water Quality / Grants Report:**

Gary Fillion, Vice Chairman, reported that he and George Knoecklin surveyed the Lake and George will compile a report; DEEP approved the Aquarion Permit for Herbicide Treatment and a date will be set shortly. Gary reported that a number of Florida Beaches are currently closed due to the presence of Blue-Green Algae.

**Boats and Motors Report:**

Dick Speer reported that Beacon Point Marina mechanic performed the twenty hour maintenance on both LZA Marine Patrol Boat engines at Eichler's Cove, Newtown and tomorrow, he will meet him at Lakeside Marina where he will install a propeller on each motor and repair the steering on Boat #2; an extra propeller will be kept on each boat.

**Coast Guard Auxiliary Report:**

Terry Bogue, LZA Driver, reported that the LZA Marine Patrol Boats will be scheduled for CGAux Safety Inspections.

**Unfinished Business:**

Ed Kusinski reported that he is awaiting the results from the FOI Hearing Officer.

**New Business:**

Ed Kusinski reported that FOI has received another complaint and an FOI Hearing has been scheduled for Thursday, July 21, 2016; he will research the information requested. Gary Fillion, Vice Chairman, stated his concerns re the length of time for the DEEP permit process and will notify his CT reps and encouraged all to do so.
