Art Fair 2014 Vendor Rules & Guidelines

1. **Advance Application required** – all artists must apply in advance; spaces are provided on a first-come, first-served basis.
2. **Booth Space** – Booth space will be assigned based on availability.
3. **Check-In / Set-Up** will begin at 5PM. Vehicles for use in transporting art & equipment will not be allowed on Bay Avenue past **5:45 PM**. All artists must be set up prior to 6pm on the day of the Fair.
4. **Permits & Sales Tax** - all artists must secure and have available upon request the proper state and/or county permit(s).
5. **NO COMMERCIALY MANUFACTURED PRODUCTS** will be permitted.
6. Organic, recycled, reused, re-created, and/or native products are **encouraged!**
7. All products sold, or materials distributed, at the NB Art Fair must be **Family-Friendly**. Any artist selling products or distributing inappropriate materials will be immediately removed from the Art Fair and banned from future participation.
8. **Erected canopies, tents, and/or umbrellas** are required to have their canopies safely anchored. Approved weight systems include sand and water bags, or the like. **The use of spikes or stakes to secure canopies is strictly forbidden.** Vendors may not attach canopies to trees, signs, or shrubs.
9. Vendors must supply all their **own equipment, including tables and chairs**. No exceptions.
10. **Electric and/or water hook - is not available.**
11. Each artist is responsible for **removing ALL of their own trash**. This includes boxes, packaging materials, booth supplies and materials, crates, etc. In other words, any items you brought, you must take home.

12. **Cordial & Welcoming** – any artist participating in a North Beach event is expected to treat all visitors and staff with the utmost respect and consideration. We are striving to create a warm and welcoming atmosphere for all visitors, regardless of age, race, religion, ability, gender, etc.

Failure to follow these rules will result in expulsion from the NB Art Fair program.
