February 1<sup>st</sup> –Motion to approve by Mr. Field, seconded by Mr. Knowles, vote to accept minutes was unanimous.

February  $22^{nd}$  – Motion to approve as amended by Mr. Wilson red-line version by Mr. Ganotis, seconded by Mr. Knowles, the vote t accept the minutes as amended was unanimous.

Next Meeting was scheduled for April 19<sup>th</sup>, 2007 at 7:30 AM in the Mary Herbert room.

At 8:00 AM, Mr. Caporossi and Mr. Hughes from the Trust for Public Land joined us.

At 8:01 AM Bob Field moved the subcommittee enter into executive session under RSA 91-A: 3(b) for the purpose to discuss projects currently pending. Stanley Knowles seconded the motion. The vote was unanimous in favor and so moved. Roll Call to enter executive session was unanimous in favor.

Project 03-15 was discussed, specifically updates from TPL regarding their negotiations, time table for the project, and identification of potential matching properties for any future CELCP funding.

A motion ensued by Mr. Harned to support the "Trust for Public Lands" proposal for acquisition of project 03-15 and was seconded by Mr. Field.

The vote was unanimous in favor 7 - 0.

Project 02-07 discussion on continued negotiations. Mr. Harned motioned to authorize Mr. Ganotis and Mr. Wilson to discuss an appraisal and staging of the easements, seconded by Mr. Field. The vote was unanimous.

Mr. Field motioned to move out of executive session. Mr. Knowles 2<sup>nd</sup> the motion. The vote was unanimous.
