

Selectmen's Minutes  
11 February 2002  
7:00pm

The Chair, Lloyd Sullivan, called the regularly scheduled public session to order at 7:00pm. Those present included George Lagassa, Jenifer Landman (Selectmen) and Russell McAllister, (Town Administrator).

### Selectmen Issues

Mr. Lagassa made the motion to approve the meeting minutes of January 28<sup>th</sup> & February 9<sup>th</sup>. Ms. Landman seconded the motion. The vote was unanimous and so moved.

The Board reviewed the Planning Board's recommendation to reduce the bonds on the above-mentioned projects. Mr. Harned (North Hampton Water Commissioner) raised the question of whether or not the wells located within Evergreen Drive had been capped per DES regulations. It was noted that capping of the wells was a condition of approval established by the Planning Board. The Board tentatively agreed to reduce the bond contingent upon the verification that the wells had been capped per DES regulations. Mr. Lagassa made the motion to approve the planning board recommendation to reduce the bond for Seacoast Indoor Tennis Club from \$34,852.40 to \$10,168.40 and to also reduce the bond for Evergreen Drive contingent upon verification that the wells had been capped according to DES regulations. Ms. Landman seconded the motion. The vote was unanimous and so moved.

Mr. Lagassa suggested that the Building Inspector attend those meeting where the planning board has need of his services. The Board agreed with the suggestion, but felt that no formal motion was necessary.
