**1. Call to Order**

Chair Maggiore called the meeting to order at 8:35 AM. Those in attendance were Selectman Wilson, Selectman Miller, Administrative Assistant Janet Facella and Acting Detective Steven Janvrin.

**2. New Business**

2.1 Large Assembly Permit- NEPBA Fundraiser

Chair Maggiore stated the permit for the New England Police Benevolent Association (NEPBA) was originally scheduled for the February 24, 2014 Select Board, however the meeting had been cancelled. The Chair further explained the event that will be held by the NEPBA, is to benefit the Seacoast Child Advocacy Center, and will be held at Local's Restaurant in North Hampton.

Chair Maggiore noted the application was received well within the 30 day period, and has been "signed off on" by all of the department heads.

Acting Detective Janvrin stated the Seacoast Child Advocacy Center relies solely on donations and grants in order to operate. He further stated it is an organization that police officers use quite a bit as it is a comfortable environment for the children to be interviewed in, as opposed to a more sterile environment such as the police station. Proceeds from the fundraiser held on March 14, 2014 will be donated to the Seacoast Child Advocacy Center.

**Motion by Selectman Miller to approve the Large Assembly permit for the New England Police Benevolent Association for their event to be held on March 14, 2014. Seconded by Chair Maggiore. Motion carries 3-0.**

The Select Board discussed a way to get a message out regarding political advertising as far as the timelines for when they can be put up and taken down.

**Motion by Selectman Wilson to announce that political signs shall be put up no earlier than February 28, 2014 and taken down no later than March 14, 2014. Seconded by Selectman Miller. Motion carries 3-0.**

At the end of the agenda, the Board provides an opportunity for visitors to address the Board on topics not on the agenda. Visitors shall state their name and address prior to addressing the Board. Public comments shall be limited to three (3) minutes per person and fifteen minutes (15) total. Following such comments the Chair may place the matter on a future agenda, or refer the matter to the Town Administrator for investigation, report or to take such action as may be appropriate. Please be aware, that due to State law, the Select Board cannot discuss personnel matters during this time. Visitors should not expect a Board response to their comments or questions.

The Board's goal for the conduct of its meeting is to accomplish its work within a qualitative period respecting the participation of visitors as well as all others who contribute to the effectiveness of its meetings. Board meetings will not last past 9PM, unless approved by a majority of the Board.

You will note several agenda items listed "**CONSENT CALENDAR**". These items will not be discussed unless any one member of the Board requests their removal from the "**CONSENT CALENDAR**". The Board will previously have received information or reports on these topics.

The Select Board will meet in regular session on the second and fourth Monday of the month with special meetings, as necessary.
