Responded regarding a barking dog complaint. While on scene, I did not hear any dogs barking. I made contact with the homeowner, who advised her 2 dogs had been inside and not barking. A subsequent check revealed that the 2 dogs are not registered. Follow-up will be conducted with Coppinger during my next shift. The calling party wished to remain anonymous. At 1000 hours, I attempted to contact Coppinger regarding the registration of her dogs. I had negative contact and a message was left for Coppinger to return my call. At approximately 1215 hours, I received a call back from Coppinger who confirmed that both of her dogs are registered (Tag numbers 000603 & 000604). Coppinger informed that she had registered the dogs recently within the month of June. I will follow-up with the Town Clerk to confirm.
