# North Stonington Board of Finance Meeting Minutes Wednesday, September 16, 2009 NEW TOWN HALL 40 Main Street, North Stonington, CT

- 1. Call to Order: Chairman M. Donahue called the meeting to order at 7:38 PM. Vice Chairman L. Southwick, G. Herbert, and E. Pavlovics were present. E. Bresette and Secretary T. Oswald were not present.

- 3. Board of Selectmen: N. Mullane, First Selectman reported that the end of year reconciliation of the Town and BOE accounts are complete. The Town Meeting to consider the deferral of the scheduled property Revaluation is scheduled for September 28. Liquidation of the surplus fire truck resulted in \$40,000 of revenue versus the budgeted revenue of \$57,500. A new walking floor trailer for the Transfer Station was procured for \$51,092 versus a budgeted expenditure of \$70,000. Mr. Mullane provided an update of the pending consolidation of Probate Courts in Connecticut, specifically relating to North Stonington. Repairs to Town Hall have been completed within budget. The conduct of an Emergency Drill last month highlighted an operational weakness of the Town's Emergency Center because it does not have a supporting power generator. The annual financial audit is scheduled to begin September 21.
