Community Preservation Committee & Town Planner Presentation

<u>Article 28 - Northborough Schools – Green Repair Project at Melican Middle School</u> - J. Hight moved to defer recommendation on this article until additional information becomes available at Town Meeting regarding the final scope of the project.

<u>Article 29 - Northborough Schools – Lincoln Street School Feasibility Study</u> - By consensus, Committee passed over article with the understanding it will be passed over, since Massachusetts School Building Assistance has not approved the project.

<u>Article 30 - Acceptance of Chapter 479 of the Acts of 2008 (OPEB Trust Fund)</u> - J. Hight moved to recommend approval; R. Nieber seconded; unanimously approved.

<u>Article 36 - Community Preservation Fund – Affordable Housing Corporation</u> - J. Hight moved to recommend approval subject to a written agreement between NAHC and the Town of Northborough; R. Nieber seconded; unanimously approved.

<u>Article 37 - Community Preservation Fund – DPW Church Street Bridge</u> - J. Hight moved to recommend approval; R. Nieber seconded; unanimously approved.

<u>Article 38 - Community Preservation Fund – Historic Reserve Revenue</u> - J. Hight moved to recommend approval; R. Nieber seconded; unanimously approved.

<u>Article 39 - Community Preservation Fund – Historical Commission</u> - J. Hight moved to recommend approval; R. Nieber seconded; unanimously approved.

Article 40 - Community Preservation Fund - Purchase land at 0 Green Street for Open Space <u>Preservation</u> - J. Hight moved to defer recommendation on this article until Town Meeting.

<u>Article 41 - Community Preservation Fund – Community Open Space Reserve</u> - J. Hight moved to defer recommendation on this article until Town Meeting since it is a contingent article which becomes moot if Article 40 passes. If Article 40 fails, passage of this Article will be necessary to meet the minimum requirements under the Community Preservation Act.

<u>Article 42 - Community Preservation Fund – Expenses Associated with Community Preservation</u> <u>Committee</u> - J. Hight moved to recommend approval; R. Nieber seconded; unanimously approved.

Discuss and make appointment to Financial Planning Committee

Committee discussed the qualifications of the various applicants. R. Nieber moved to appoint Richard Smith to the Financial Planning Committee; D. McInnis seconded; unanimously approved.
