# **ELECTION OF OFFICERS**

#### **APPROVAL OF MINUTES**

After a brief discussion the Committee decided to hold off on the approval of the April 28, 2014 meeting minutes until the next meeting.

#### **FY14 YEAR END TRANSFERS**

The Town Administrator reviewed the June 30, 2014 memo prepared for the Committee regarding yearend transfers. The FY2014 Snow and Ice appropriation ended with a \$268,120 legal deficit. In keeping with the Town's practice of covering current year costs within the same fiscal year, the staff proposes the following transfers be made:

# **Department to Transfer From:**

Reserve Fund \$150,000 Health Insurance \$118,120

#### **Department to Transfer To:**

Snow & Ice \$268,120

- R. Nieber moved the Committee vote to transfer \$150,000 from the Reserve Fund to the Public Works Snow and Ice Removal (Dept. #14423) for the purpose of closing the legal deficit in the FY2014 Snow and Ice Appropriation; D. McInnis seconded; motion approved unanimously.
- R. Nieber moved the Committee approve and recommend the transfer of \$118,120 from the Health Insurance (Dept. #18855) to Public Works Snow and Ice Removal (Dept.#14423) to close the legal deficit in the FY2014 Snow and Ice appropriation; D. McInnis seconded; motion approved unanimously.
