The Board of Health met on Tuesday, August 13, 2013, in the Selectmen's Meeting Room of the Northborough Town Offices. The meeting was called to order at 6:00 PM by Chairman Glenn French.

6:00 PM

Consideration of the May 14, 2013 minutes. Chairman Glenn French made a motion to approve the minutes as written for the May 14, 2013 meeting. Dilip Jain seconded the motion and the vote was unanimous.

Consideration of the June 11, 2013 minutes. Chairman Glenn French made a motion to approve the minutes as written for the June 11, 2013 meeting. Deirdre O'Connor seconded that motion and the vote was unanimous.

Final Tobacco regulation review and vote for possible adoption

The Board reviewed Town Counsel recommendations and discussed the recent decision for the Canton Board of Health adopting 21 years of age restriction.

After the discussion the Board review of the draft regulations. Chairman Glenn French made a motion to approve the regulations as written. Deirdre O'Connor seconded the motion. The vote was unanimous. The effective date of these regulations is 8/13/13.

175 Bearfoot Road / Iron Mountain Records Management - Gerald Buzanoski, Septic Variance Request - Depth of cover over septic tank

The Board heard from Gerald Buzanoski on this evening. Mr. Buzanoski discussed the existing conditions at 175 Bearfoot Road and what the proposed changes would entail. The existing septic tank exceeds the allowable cover over the tank. Mr. Buzanoski explained that to change the elevation of the septic tank the

existing floor would need to be jackhammered and would create significant burden. The Board of Health has approved depth over 3' in the past in a similar circumstance. Chairman Glenn French made a motion to approve the additional depth of cover over the septic tank. Deirdre O'Connor seconded the motion. The vote was unanimous.

5 Weber Lane - Well regulation offset for irrigation well - David Veron - Veron Company

Mr. Veron represented 5 Weber Lane this evening regarding the desire of the home owner to install an irrigation well. The Board requested the location of the well to maintain the required offset to the property line and be moved closer to the Road if needed. Chairman Glenn French made a motion stating at the discretion of the Health Agent the road offset may be approved once a plan is provided by a Professional Engineer. Dr. Dilip Jain seconded the motion. The vote was unanimous.

Ms. Terry and the Board discussed the recent food inspections that were completed; no outstanding issues were reported.

Ms. Terry and the Board discussed recent housing, trash and environmental complaints that she has received.
