#### **APPROVAL OF MINUTES – JUNE 14, 2010 REGULAR MEETING**

Selectman Amberson moved the Board vote to approve the Minutes of the June 14, 2010 Regular Meeting as presented; Selectman Rutan seconded the motion; all members voted in favor.

# 7:00 p.m. - BOB MIHALEK, TRAILS COMMITTEE CHAIR

Update on the continuing efforts of the Trails Committee.

Chairman of the Trails Committee Bob Mihalek was present to provide an update on the Committee's continuing efforts to develop and maintain a viable trail system on public and private property throughout the Town. Some of the Committee's routine work includes mowing grass, removing fallen trees, brush cutting and hedge trimming, bridge repairs, and stocking maps in the trail mailboxes. The Committee also works with local Eagle Scouts on volunteer projects.

Mr. Mihalek acknowledged the contributions from local organizations and the Community Preservation Committee. Copies of maps of the various trails in Town were provided to members of the Board. Residents can obtain copies of updated maps on the Town website.

## 7:10 p.m. - **JOHN CAMPBELL, OPEN SPACE COMMITTEE CHAIR** Update on the Status of the Open Space and Recreation Plan.

Chairman of the Open Space Committee John Campbell was present. Mr. Campbell summarized the process undertaken to update the Open Space and Recreation Plan. He added that in addition to monthly meetings, community involvement was provided by means of a survey posted on the Town's website and additional comments will be taken at a public forum to be held on August 2<sup>nd</sup>. A copy of the draft Open Space and Recreation Plan Update is available on the Town's website.

Mr. Campbell added that letters of support have been received from the Conservation Commission, Planning Board, Trails Committee and the Parks & Recreation Commission. He requested a letter of support from the Board of Selectmen as well. The Plan will then be submitted to the MA Division of Conservation Services for final review and approval.

# 7:25 p.m. - MARK LEAHY, POLICE CHIEF

Appointment of Special Police Officers.

Chief Leahy informed the Board that reappointment of Special Police Officers is not necessary at this time due to the death of Frank Mueller and the resignations from Thomas Martin and Edward Shead.

Selectman Amberson moved the Board vote to accept the resignations from Thomas Martin and Edward Shead as Special Police Officers effective immediately; Selectman Rutan seconded the motion; all members voted in favor.

# 7:25 p.m. - JUNE HUBBARD-WARD, FINANCE DIRECTOR

Approval of the Advances in Lieu of Borrowing.

Ms. June Hubbard-Ward was present to request that the Board approve internal funding for three projects through the "Advances in Lieu of Borrowing" procedure. The following debt authorizations were approved at previous Annual Town Meetings:

## Status Report on Future Solid Waste Bids

Mr. Litchfield summarized the proposed timeline for the solicitation of formal bids for solid waste and recycling collection services. The proposed schedule is being started much earlier than normal to allow for a full and complete analysis of the options and discussion with the Board of Selectmen and other Financial Boards during the FY12 Budget Review Process.

#### Approval of Amended Order of Taking for Silas Drive

Mr. Litchfield informed the Board that the original Order of Taking for Silas Drive was rejected by the Registry of Deeds because one of the landowners was not shown on the final plan. The landowner in question has been added to the list and the amended Order of Taking will be resubmitted.

Selectman Bakstran moved the Board vote to approve and execute the amended Order of Taking for Silas Drive; Selectman Amberson seconded the motion; all members voted in favor.

## REPORTS

<u>Fran Bakstran</u>

- Congratulated Nicholas Hurtz for achieving the rank of Eagle Scout.
- Noted that the Interview Committee met with applicants for the Cultural Council and Community Affairs Committee. See below for appointments.
- Noted that the recent publication "Here's to Water" published by the Massachusetts Water Resources Authority was very informative and confirmed that the quality of our tap water is excellent.
- Announced that the Annual Applefest Celebration will be held during the weekend of September 10-12<sup>th</sup>. Contact Michelle Gillespie at 393-3155 for additional information.
- Provided an update on the continuing efforts of the Wind Committee in gathering wind data to determine if there is a suitable site on or within a one-mile radius of Tougas Farm.
- Announced that the Wind Committee will hold a public ribbon cutting ceremony on August 5<sup>th</sup> at 2 p.m. to publicly acknowledge the met tower at Tougas Farm. Added that if this site proves to be viable, a wind turbine that would be used strictly for municipal service only and could produce half of the energy that the municipal government would need.

- Thanked Allison Lane and the Recreation Department staff for coordinating and running the summer programs.

 Noted that he has been approached by local business owners about the lack of enforcement regarding sandwich board signs. Mr. Coderre informed the Board of a recent campaign by the Building Inspector in which all business owners were advised of the Town's bylaw that prohibits these signs under most circumstances. Business owners are advised to contact the Building Department with any questions or concerns.

## **APPROVAL OF BIKE RACING EVENT - AUGUST 15, 2010**

Eric Averill from Sun Multi Sports Events was present to request permission for the biking portion of the Westborough Sprint Triathlon to run through Route 20 in Northborough. It is expected that 200-250 participants will pass through Northborough on bicycles on August 15th between 8:15 a.m. - 9:15 a.m. The route will begin on South Street, onto Brigham Street, heading east on Main Street onto Bartlett Street and then continuing until they enter Marlborough.

Mr. Averill added that a portion of the proceeds from the event will go to the Leukemia and Lymphoma Society in memory of a past member of the Westborough Rotary Club.

#### APPROVAL OF BIKE RACING EVENT - AUGUST 15, 2010 CONT...

Mr. Averill confirmed that he has been made aware and is agreeable to the conditions recommended by the Police and Fire Departments.

Selectman Bakstran moved the Board vote to allow a bike race over state highway 20 through the Town of Northborough on August 15, 2010 with the condition that the applicant shall be responsible for the strict adherence to the agreed-upon plans as outlined in the letters dated July 12, 2010 from Sergeant Galvin and July 8, 2010 from Fire Chief Durgin, as well as any and all related expenses; Selectman Rutan seconded the motion; all members voted in favor.

#### MEMORANDUM OF UNDERSTANDING WITH NEDP, INC.

Mr. Coderre informed the Board that the annual Memorandum of Agreement between the Town and Extended Day Program, Inc. is for the continued use of office space and facilities at the Town Hall. This updated Agreement for FY11 provides for an increase in payment to the Town from \$16,300 in FY10 to \$17,500 in FY11 to reflect increased costs associated with use of the space, as well as the shared Administrative Assistant position.

Selectman Rutan moved the Board vote to approve the FY11 Memorandum of Understanding between the Town and Northborough Extended Day Program, Inc. for the use of office space and facilities at the Town Hall and to authorize the Town Administrator to execute same; Selectman Amberson seconded the motion; all members voted in favor.

#### **REAPPOINTMENT - DISTRICT DIRECTOR, BURIAL & VETERANS AGENT**

Selectman Pantazis moved the Board vote to reappoint Richard Perron to serve as the Town's Burial Agent and Veterans Agent, as well as the District Director for the Towns of Northborough, Shrewsbury and Grafton for a one-year term; Selectman Rutan seconded the motion; all members voted in favor.

#### APPROVAL/EXECUTION OF CEMETERY DEEDS A837, A838 & A839

Selectman Pantazis moved the Board vote to approve and execute Cemetery Deeds A837, A838 & A839; Selectman Amberson seconded the motion; all members voted in favor.
