APPROVAL OF MINUTES - MARCH 24, 2014 REGULAR MEETING

Selectman Rand moved the Board vote to approve the meeting minutes of the March 24, 2014 regular meeting as submitted; Selectman Pantazis seconded the motion; all members voted in favor.

7:00 p.m. - SCHOLARSHIP COMMITTEE

Presentation of Scholarship Awards.

Scholarship Committee Chair Bob D'Amico was present along with Committee members Kelly Moran and James Kihungi. Mr. D'Amico introduced students Ariel Thompson and Michael McGregor as the 2014 Scholarship recipients. Ms. Thompson and Mr. McGregor were present with their families and each was awarded \$500.

7:05 p.m. - ASHLEY DAVIES, SUDBURY VALLEY TRUSTEES

Approval/Execution of Schunder Conservation Restriction.

Town Engineer Fred Litchfield introduced Ashley Davies from the Sudbury Valley Trustees. Ms. Davies is also a member of the Open Space Committee.

Ms. Davies informed the Board that the Green Street Conservation Restriction was made possible by funds provided by the Community Preservation Act (CPA) and the Town Meeting vote of Article 40 at the 2011 Annual Town Meeting. The use of CPA funds to acquire land requires the restricted premises be protected with a conservation restriction, which in this case will be held by Sudbury Valley Trustees, Inc.

Mr. Litchfield stated that the Trails Committees has already constructed some trails on this property and the DPW Department has constructed a parking area in order to provide safe off street parking. He added that the Conservation Commission approved and executed the Green Street Conservation Restriction at their meeting on March 10, 2014.

Selectman Pantazis moved the Board vote to approve and execute the Green Street Conservation Restriction to be held by the Sudbury Valley Trustees in accordance with Article 40 at the 2011 Annual Town Meeting; Selectman Hutchins seconded the motion; all members voted in favor.

Aaron Hutchins

- Requested an update from Town Engineer Fred Litchfield about the traffic signal at the Route 20/Hudson Street intersection in terms of Hudson Street traffic controlling the traffic flow on Main Street. Following a brief update, Selectman Hutchins extended his appreciation to Mr. Litchfield for his follow-up efforts regarding his concerns.

- Announced that the second week in April is National Public Safety Telecommunicators Week in recognition of the men and women who serve as public safety dispatchers.
- Encouraged residents to attend the Annual Town Meeting.

APPOINTMENT TO THE 250TH TOWN ANNIVERSARY COMMITTEE

Selectman Pantazis moved the Board vote to appoint Thomas Lowe to the 250th Town Anniversary Committee for a three year term; Selectman Rand seconded the motion; all members voted in favor.

PUBLIC COMMENTS

PRESENTATION ON FY2015 CAPITAL BUDGET

Mr. Coderre made a presentation to the Board on the proposed FY2015 Capital Budget. The presentation included an overview of the recommended Capital Budget Projects included in the Town Meeting Warrant as Articles 21 through 34.

PRESENTATION ON FY2015 CAPITAL BUDGET CONT...

The total FY2015 Capital Budget is \$3,079,500. The \$939,500 in General Fund projects will be funded entirely by sources that will result in no new tax impact for residents. The Water & Sewer Capital projects will be funded through a combination of Enterprise Fund Free Cash (\$165,000) and Debt Service (\$1,975,000).

Mr. Coderre noted that the Financial Planning Committee and the Appropriations Committee unanimously recommend approval of the FY2015 Capital Budget.

Following Mr. Coderre's presentation, several questions and comments were heard from members of the Board.

SPECIAL FUND REQUEST – 250TH TOWN ANNIVERSARY COMMITTEE

Mr. Coderre informed the Board that the 250th Town Anniversary Committee is requesting that the Board of Selectmen establish a Special Fund under Massachusetts General Law, Chapter 44, Section 53I for the purpose "settlement or incorporation celebrations".

Chairman Rutan read aloud the mission statement of the 250th Town Anniversary Committee.

Selectman Pantazis moved the Board vote to establish a Special Fund under Massachusetts General Laws, Chapter 44, Section 53I for use by the 250th Town Anniversary Committee for the purpose of event planning for the Town's 250th Anniversary in 2016; Selectman Rand seconded the motion; all members voted in favor.

REAPPOINTMENTS TO BOARDS, COMMITEES AND COMMISSIONS

Selectman Hutchins moved the Board vote to reappoint those individuals who appear on the "2014 Reappointment List" to the corresponding Boards, Committees and Commissions; Selectman Pantazis seconded the motion; all members voted in favor.

ASSIGNMENT OF TOWN MEETING WARRANT ARTICLES

Members of the Board agreed on which Warrant Articles each of them would present at Town Meeting.

VOTE ON TOWN MEETING WARANT ARTICLE RECOMMENDATIONS

The Board agreed to make a formal recommendation on the following Budget Warrant Articles at the Annual Town Meeting:

Selectman Rand moved the Board vote to recommend Articles 4, 5, 6 & 19 at the Annual Town Meeting; Selectman Pantazis seconded the motion; all members voted in favor.

Selectman Rand moved the Board vote to recommend Articles 43, 44, 45 & 46 at the Annual Town Meeting; Selectman Pantazis seconded the motion; all members voted in favor.

Selectman Rand moved the Board vote to recommend Articles 58 & 59 at the Annual Town Meeting; Selectman Pantazis seconded the motion; all members voted in favor.

SET MEETING SCHEDULE FOR MAY – AUGUST

Selectman Pantazis moved the Board vote to set the meeting schedule for May through August as follows:
