#### APPROVAL OF MINUTES – SEPTEMBER 8, 2014 REGULAR MEETING

Selectman Amberson moved the Board vote to approve the meeting minutes of the September 8, 2014 regular meeting as submitted; Selectman Perreault seconded the motion; all members voted in favor.

### 7:00 p.m. - HEARING - DPW DIRECTOR DANIEL NASON

Set Fees for Plowing/Sanding Private Ways for the upcoming 2014-2015 winter season.

DPW Director Dan Nason proposed to the Board that the base charge for plowing and treatment services of private ways and unaccepted streets which are 100% complete be increased approximately 3% from last year to cover the increased costs of labor, equipment maintenance, sand, salt and other materials, and fuel.

Based on the high increase in treatment services, Selectman Amberson suggested taking another look at increasing the fees. Mr. Coderre stated that he feels comfortable moving forward with the proposed fees this evening as this was the information forwarded to the private way residents.

Residents of the private ways that received plowing and treatment services during the last Winter Season were notified of tonight's hearing to increase the fees. None were present.

Selectman Perreault moved the Board vote to set the fees for plowing and treatment of private ways less than 3,000 feet for the 2014/2015 winter season as follows:

\$180.00 per storm for plowing \$180.00 per storm for treatment services

Selectman seconded the motion; all members voted in favor.

Attorney Howard Lane was present along with the proposed manager Bryan Hogan. Mr. Hogan has been with BJ's since 2011. Prior to that he worked at Target for seven years. Mr. Hogan is TIPS certified.

Detective Sergeant Brian Griffin conducted a background check on Mr. Hogan and did not find anything of concern.

Selectman Amberson moved the Board vote to approve the application from Mormax Corporation d/b/a BJ's Wholesale Club to change the manager of their All Alcoholic Beverages Package Store License from Diane Mareira to Bryan Hogan for premises located at 6102 Shops Way; Selectman Rutan seconded the motion; all members voted in favor.

#### Jason Perreault

- Expressed his concern with the current configuration of the downtown traffic signal control at Church and Pierce Street. DPW Director Dan Nason indicated that it is still under review with Mass DOT.
- Attended the recent dedication ceremony for the new basketball courts at the Proctor Elementary School. Thanked the Community Preservation Committee for their help in funding the project.
- Attended the Memorial Services for Brian Arsenault on September 16<sup>th</sup>. Thanked the Town Administrator, Police, Fire and DPW departments for their combined efforts in preparing for the services.

- Attended the Applefest celebration. Thanked all who participated and who helped to coordinate the annual event.

#### Leslie Rutan, Clerk

- Requested an update on the proposed pipeline project. Mr. Coderre indicated that he and Town staff recently met with representatives from Tennessee Gas Pipeline. The pipeline is not expected to impact Northborough, with the exception of ten properties located in the Ball Hill area. The company is communicating directly with those home owners and there have been no complaints or concerns to date.

- Noted that the bridge repair project on Route 20 near the Police Station has recently been completed.
- Requested that the DPW Department investigate alternatives that will help to prevent the overgrowth of bushes near the Assabet Playground.

- Announced that Helping Hands is holding their 6<sup>th</sup> Annual Winter Gear Drive. They are accepting new or gently used coats, pants and boots infant size to teens. Drop off locations are located at Town Hall, the Library and at all the schools.
- Asked residents to check out the Peaslee School Website. Added that they are holding a fundraiser for a new playground. The playground is over 20 years old and needs to be replaced.

- Spoke about the Memorial Services for Brian Arsenault, adding that the community support was overwhelming.

#### Dawn Rand, Chairman
