Discussion of Legislative Priorities.

In preparation for tonight's legislative update, letters were sent to the State Legislators advising them of Northborough's legislative priorities. At the request of the Board, Senators Chandler and Eldridge and Representative Gregoire were present. Representative Harold Naughton was not able to attend. Also present in the audience were School Superintendent Christine Johnson, School Business Director Cheryl Levesque and Northborough School Committee members Joan Frank and Patricia Kress.

Mr. Coderre reviewed the top two municipal legislative priorities relating to Chapter 90 Roadway Repair Funding and Other Post-Employment Benefits (OPEB) Legislation Reform. School Superintendent Christine Johnson spoke to the top legislative priority relating to the State Special Education Circuit Breaker Program.

Senators Chandler and Eldridge and Representative Gregoire spoke at length to the priorities discussed above, as well as to the State Budget as a whole. Each offered their support and their commitment to continue to advocate on behalf of the Town and the School District. Each also noted their support of the need for continued focus on unfunded mandates.

Lastly, Mr. Coderre discussed his concerns with the redraft of the public records bill.

Mr. Coderre, Ms. Johnson and members of the Board thanked the Legislators for coming in this evening and for always being attentive to the needs of Northborough.

7:10 p.m. - KATHY JOUBERT, TOWN PLANNER JOHN CAMPBELL, COMMUNITY PRESERVATION COMMITTEE CHAIR

Presentation on Town Meeting Warrant Articles - Request for Funding from the Community Preservation Fund.

Community Preservation Chairman John Campbell was present. Town Planner Kathy Joubert was not able to attend tonight's meeting. Mr. Campbell reviewed the seven articles below, representing \$712,700 in CPA allocations that were approved by the Community Preservation Committee for inclusion on the 2016 Annual Town Meeting Warrant.

- \$4,900 Historic District Commission for signs relating to historic sites.
- \$2,000 Historic District Commission to conduct a property line survey of the Old Brigham Street Burial Ground.
- \$54,000 First Parish Unitarian Universalist for restoration and accessibility improvements at the Church and Meeting House located at 40 Church Street.
- \$100,000 Northborough Affordable Housing Corporation for the creation of affordable housing.
- \$480,000 Department Public Works for the creation of a town common at 39 and 45 West Main Street. (Phase I of 2 phases).
- \$46,800 Debt service associated with purchase of Green Street parcel.
- \$25,000 CPC administrative expenses associated with implementation of Community Preservation Act.

Following the presentation, several questions and comments were heard by members of the Board. The Board extended their appreciation to Mr. Campbell and to all the members of the Community Preservation Committee.
