Mr. Motameri, representative for 318 Main Street, explained that the abutters were notified/signature cards and submitted to Mr. Litchfield. Mr. Motameri gave an update on the property and plans to open the "Tavern on the Square" restaurant by June 1st. Mr. Litchfield explained that tonight's meeting was to formalize the process and issue a permit; Board members discussed the plans, parking lot, no tree removal, and water line connections (anticipated starting on April 15th).

Board members briefly reviewed the plans and the bond amount agreed at \$20,000 (already posted with the Treasurer's office). Mr. Litchfield explained that the bond was posted and the permit would need the Earthwork Board's approval and signatures before being issued. Ms. Sandstrom asked if any abutters were present; no one responded. Ms. Sandstrom requested action.

Mr. Philcox motioned, Mr. Pini seconded, and it was unanimously voted, "To issue an Earthwork Board permit for 318 Post Road Corporation for the property at 318 Main Street, Map 47, Parcel 93 with a bond amount of \$20,000."
