Earthwork Board 63 Main Street, Northborough, MA 01532 Conference Room B Wednesday, January 28, 2015

Present: Janet Sandstrom, Tom Beals, Fred Philcox, Anthony Ziton, and Tony Pini

At 7:00 pm, Ms. Sandstrom called to order the Earthwork Board meeting.

Public Hearings:

Renewal Permit Northborough Commons, LLC 61-65 West Main Street Map 63, Parcels 9 & 10

Mr. Jim Vogel presented his plan for commercial and residential development at 61 - 65 West Main Street. Mr. Vogel indicated they have performed some soil borings, no ledge was found and the soils were as predicted in the original drainage analysis. Mr. Vogel also indicated he plans to start construction in the spring of 2015. Mr. Vogel also presented some pictures of the proposed buildings which were approved by the Design Review Committee.

Mr. Philcox asked if both of the existing buildings were scheduled to be demolished and Mr. Vogel said yes both would be demolished. Mr. Philcox asked how the rear of the property would be accessed and Mr. Vogel said there would be access through the center of the site between the two proposed buildings.

Mr. Beals moved to issue a renewal permit with the same bond amount of \$17,500, the motion was seconded by Mr. Philcox and unanimously approved.

Renewal Permit TShay, LLC 137 West Main Street Map 63, Parcel 89

Mr. Litchfield explained to the Board he received an email from Vito Colonna the engineer for the remaining projects on the agenda. The email requested the permit at 137 West Main Street be renewed and construction should be completed within the next twelve months or this year and the other two projects were requesting an extension to the Board's February meeting.

Mr. Beals moved to issue a renewal permit with same bond amount of \$5,500, the motion was seconded by Mr. Philcox and unanimously approved.

New Permit Mohamad Z. Ramadan 0 Newton Street Map 7, Parcel 1

The Board acknowledged the request for an extension submitted by Vito Colonna the engineer for the project as previously discussed. Mr. Beals moved to continue the public hearing to Wednesday, February 25, 2015, the motion was seconded by Mr. Pini and was unanimously approved.

New Permit Mali I Realty, LLC 25 West Main Street Map 63, Parcels 154 & 166

The Board acknowledged the request for an extension submitted by Vito Colonna the engineer for the project as previously discussed. Mr. Beals moved to continue the public hearing to Wednesday, February 25, 2015, the motion was seconded by Mr. Pini and was unanimously approved.
