The Board acknowledged the request for an extension submitted by Vito Colonna the engineer for the project as previously discussed. Mr. Philcox moved to continue the public hearing to the next meeting, the motion was seconded by Mr. Pini and was unanimously approved.

New Permit  
Mali I Realty, LLC  
25 West Main Street  
Map 63, Parcels 154 & 166

The Board acknowledged the request for an extension submitted by Mike Sullivan the engineer for the project as previously discussed. Mr. Philcox moved to continue the public hearing to the next meeting, the motion was seconded by Mr. Pini and was unanimously approved.

Renewal Permit  
Kendall Homes, Inc.  
150 Church Street  
Map 55, Parcel 60

John Grenier, engineer for Kendall Homes presented the plan for 150 Church Street and indicated he was here seeking a renewal permit as the construction did not start until recently. Mr. Grenier submitted the green cards for the notification to the abutters. The work to date includes some grading, tree removal and demolition of the existing buildings. Mr. Grenier said work will not resume until the weather permits. Funds have been posted as required in the original permit and the applicant is requesting the permit be renewed with the same bond amount and all of the same conditions.

Mr. Philcox moved to close the public hearing and to renew the permit with the same conditions and bond amount as previously approved, the motion was seconded by Mr. Pini and was unanimously approved.

New Permit  
Sterling Court Building Company  
29 East Main Street  
Map 53, Parcels 105

Jesse Johnson presented the plans for the Sterling Court residential subdivision off East Main Street. The subdivision consists of four new lots on a new subdivision road with one existing home to remain on a newly configured lot. Mr. Johnson indicated the site is basically a filled site and no material will be removed from the site. The site contains a natural low spot which will function as place for the stormwater to gather during construction and ultimately be configured as a post construction sedimentation basin. Mr. Johnson indicated all trucks leaving the site w

Joan Bertonazzi, 7 Verjuniel Way concerned about ledge and stormwater flow. Mr. Johnson indicated the soil tests did not indicate any ledge and the site is below the neighbor's site and no stormwater will be flowing in the direction of Verjuniel Way.

Mr. Litchfield explained he has estimated the bond for this project at \$17,00 which breaks down as:  
\$6,700 for a bulldozer  
\$5,400 for hydroseeding  
\$2,400 for as-built drawings  
15% contingency

Mr. Pini moved to close the public hearing and to issue a new permit with the standard conditions and a bond amount of \$17,000 the motion was seconded by Mr. Philcox and was unanimously approved.

**New Business:** The Board discussed the need for a change to the Earthwork Bylaw and the Town Engineer explained this change would be discussed further with the Town Planner at a public hearing next month at the regular meeting of the Earthwork Board. The proposed change would return to the responsibility of issuing an Earthwork Permit to the Earthwork Board for projects located within an Industrial District which currently is done by the either the Planning Board or the Zoning Board of Appeals.
