Site Selection Matrix

Mr. Davis presented draft criteria for a site evaluation matrix. The Committee discussed the criteria and the potential weighting of each item. By consensus, the Committee agreed that the proposed criteria reflect the consideration that will be important in ranking sites, but agreed to consider further refinements that Mr. Davis and his team may propose.

Request for Information

Following a discussion regarding how best to proceed with identifying any and all potentially available sites, the Committee agreed that the issuance of a Request for Information from property owners in a defined area of the downtown (within a geographic area that would allow the Department to maintain its current response times) could provide the Committee with information about potential available properties that are not currently being actively marketed as for sale. The RFI would seek to identify potential sites, but any subsequent negotiation or purchase would be subject to a separate Request for Proposals process in accordance with Massachusetts procurement laws.

Suitability of Current Site

Following a review of the architect's updated programmatic analysis of space needs, the Committee concluded that the current fire station site at 11 Pierce Street is insufficient to support the Department's programmatic needs unless the Town acquires additional adjacent property. Ms. Kelly moved the Committee vote that the existing site, as is, does not support the programmatic needs of the Department and any renovation or expansion would require the acquisition of additional land; Mr. Cohen seconded the motion. All members voted in favor.

APPROVAL OF APRIL 3, 2018 MEETING MINUTES

Mr. Cohen moved the Committee vote to approve the meeting minutes as presented; Ms. Kelly seconded the motion. Vote: 6-0-1 (Mr. Smith abstained as he was not present at the meeting).

NEXT COMMITTEE MEETING

The next committee meeting will be held at 11:00 A.M. on Wednesday, May 23, 2018 in the Selectmen's Meeting Room at Town Hall.

OTHER BUSINESS

Site visits to recently renovated or newly built fire stations in Holden, Westborough, Uxbridge, Belmont and Newton have been confirmed for May 1st and May 10th. These will be informational site visits only with no deliberation or voting.
