Meeting called to order by Chairman at 7:10PM.

Brigham Street Cemetery

- An email was sent to John Coderre requesting that a no dumping sign be placed at the cemetery, to deter people from dumping their yard waste.
- It has been reported to the NHC that there is more than yard waste being dumped in the cemetery. Recently there has been an old swing set dumped on the property. Norm will follow up with John Coderre.
- Craig Schofield's property abuts the cemetery and he discussed his concerns about the dumping into the cemetery. He mentioned that for 10 years the Parks Department had kept up with maintenance of the cemetery. Also he mentioned that many of the Hemlock trees are infected with Hemlock woolly adelgids, a type of tree bug.
- New information has been found that there is an historic road on the western edge of the cemetery.
