Chairman called the public hearing to order at 7:00PM.

- Public Hearing: 255 Hudson St. demolition delay
 - House needs a lot of work. Foundation/beams are not up to code. Height of ceiling and stairs are not up to code
 - o Heating not up to code
 - Walk thru
 - Norm, Brian, and Bob walked through the property
 - Is the property historically significant?
 - o It is on the Chapinville historic map.
 - o Bob researched the property at the historical society.
 - There was no specific historical information on the property.
 - The architecture is corrupted inside and outside.
 - The addition is in a different era barn is from the 60s
 - The buyer is willing to look into having some similar architectural design on the new building.
 - Norm Corbin made a motion that 255 Hudson St. is neither historically nor architecturally significant and Amy White seconded the motion. It passed unanimously.
 - Norm will draft a letter to the Board of Selectmen that the property is not historically significant.
 - The public hearing closed at 7:20PM

 - The new railing needs to be safe and deleaded
 - He would like to keep it as historically relevant as possible
 - Mr. Garcia would like to work on the design for the future
 - The current style is not safe.
 - o Also, Mr. Garcia will be working on the columns, but this style will not change.
 - Amy White made a motion that the restoration work at 27-29 Whitney Street falls under the
 certificate of appropriateness. Leslie Harrison seconded and five members of the commission
 accepted the motion. One member (an abutter to the property) abstained.

 - o Representative for the Unitarian Church
 - o Would like a letter of support from the NHDC for a CPC funding request
 - o CPC Funding request includes the following
 - Install a wheelchair ramp (appx. \$9,000.00)
 - Pews are not handicap accessible for a wheelchair
 - Proposing the first two pews to be renovated to provide access for a wheelchair and a person with him/her.
 - o It would be a partial pew (appx. \$750.00)
 - Steeple There is water damage that has leaked into the 2nd floor of the church
 - Would like to refurbish it (appx. \$38,000.00)
 - Windows replace the windows (appx \$28,000.00)
 - Norm Corbin made a motion to write a letter of support for the CPA application for the First Parish Church. Bruce Chute seconded the motion, and five commission members accepted the motion, and one member (an abutter to the property) abstained from the vote.
