Meeting Minutes for Monthly Meeting Wednesday March 18, 2015

Chairman called the monthly meeting to order at 7:03.

- Historic US Route 20 Association
 - Bryan Farr presented to the NHC
 - He set up the organization to find out more information about Route 20.
 - Now people are contacting the organization
 - It's becoming a tourist destination to drive on route 20
 - Rte 20 goes from Massachusetts to Oregon
 - It's a cross country highway he wants people to think nationally but act locally
 - Rte 66 and Rte 20 were created on the same day
 - Would like people to say "Historic Route 20."
 - Cannot think of it only as the Boston Post Road. The Post Road is only 33 miles. Route 20 is 153 miles long in Massachusetts.
 - 1926-1932 Rte 20 was between Northborough and Palmer
 - Later Rte 20 was moved further south.
 - Some national maps eliminate US 20
 - The organization would like to promote historical markers along Rte 20.
 - These are historical markers, not highway markers.
 - The color is brown for historic significance.
 - The signs are the same used to designate historic route 66 and US 6.
 - It would be placed on the historic Route 20 not necessarily on the current Route 20.
 - How to place
 - Pass legislation in the commonwealth to designate US Route 20 as an historic road.
 - Get MassDOT approval on State highway sections to place markers for each town
 - Local approval to place markers on town maintained roads
 - Private property

- They are 24x36 and cost \$90.00 each (minimum 2 per town (east/west))
- o 12x24 \$25.00 each
 - Great to place in small businesses, historic sites, promotional pieces
- Each town is responsible for erecting costs, poles hardware, and labor
- Impact increase tourism, and increase in sales

 - Alternates
 - We can have up to 7 alternates.
 - Diane's recommendation is to keep the alternates.
 - Town Meeting Article, Merging Commissions (Slides for Town Meeting)
 - \circ $\,$ We need to supply slides for our two articles at Town Meeting $\,$
 - White Cliffs Preservation Restriction Update
 - Norm wrote a rough draft for the MHC to reconsider their decision.
 - Norm sent letters
 - to an architect in Portsmouth
 - A boutique hotel in Boston
 - All have experience working with historical properties
 - Ruth Chris Steak House
 - Town's 250th Celebration
 - \circ Gala has been scheduled January 30th
 - Opening ceremony on January 24, 2016 (Unitarian Church will include a donated cake by "The Cake Boss" from New Jersey)
 - There will be a request on the Town Warrant for 20,000 to go toward the 250^{th} celebration.
 - Historic House Plaque Program
