7:00 PM Northborough Wind Turbine Committee (WTC) called to order

- 1. The meeting began with a welcome by the co-chairman, introductions around the table, and acceptance of the June 8th meeting minutes.
- 2. A revised meeting schedule through August 18th was issued by R. Giles.
- 3. An update on the met tower installation was provided via e-mail by M. Vanderbrook (see SED memo dated June 23, 2010). The installation is scheduled for mid-July 2010.
- 4. A copy of the Worcester Telegram June 23rd article regarding the Cape Wind project public hearing was provided.
- 5. The Wind Turbine technical information binder will continue to be routed through the group. All reviewers agreed the tech data was helpful. R. Kane currently has the binder for review.
- 6. The WTC was provided with a 6/10/2010 note from J. Codere the Town of Washington, MA is seeking support to keep wind turbine siting, construction, operations, infra structure upgrades limited to approvals at the local versus state level. Comments from the WTC are invited.
- 7. A National Grid handout was provided for WTC review on net metering.
- 8. A Power Point presentation prepared by five Algonquin high school students (S. Brillhart, J. Graham, C. Ferguson, R. Wales, K. Winkler) on the Cape Wind project was provided for WTC information purposes. Supplemental AWEA data, failure tables and excerpts from the Cape Wind environmental impact study were also provided. The WTC wishes to thank the students for their input.

- 9. Individuals/officers are needed to complete the 501C application for "Friends of the Wind Turbine" and establish the non-profit corporation.
- 10. M. Harling reported WTC table space for the fall Applefest celebration was purchased. Funds are need for brochures etc.
- 11. Latest progress on the composite Town Electric bills was provided. Total annual cost may be closer to \$800,000. After a detailed review of the high school information provided by M. Gorman, a meeting will be scheduled with F. Litchfield and K. Hood to review the municipal costs (fire, town hall, police, DPW)
- 12. A meeting with Sen Chandler will be scheduled to continue the APR land use discussion with the Department of Agriculture.
- 13. R. Jones presented a preliminary department head briefing Power Point presentation for WTC review.

From earlier meeting notes:

- 14. M. Harling recommended that both US Senators Kerry and Brown be advised of the WTC activities and objectives.
- 15. Once a date for the met tower erection is determined, WG-4 will need to schedule video taping, participant notifications, photo-ops, community updates, etc.
