7:00 PM Northborough Wind Turbine Committee (WTC) called to order

- 1. The meeting began with a welcome by the co-chairman, introductions around the table, and acceptance of the June 23 meeting minutes.
- 2. An update on the met tower installation was provided by M. Vanderbrook
 - a. Cement blocks were used for anchor point due to ground conditions
 - b. There are six anemometers, two wind vanes installed for redundancy
 - c. Measurements are recorded in the data logger at the base of the tower
 - d. Data will be retrieved on a monthly basis.
 - e. SED will provide a monthly summary report and a six month interim report to keep the WTC informed of the measurements. The feasibility study will then be completed in a year.
 - f. SED will obtain the data card with assistance from the Northborough Engineer/WTC as needed
 - g. Other Topics
 - 1. SED was asked to provide a typical cost for a mile of 13kV distribution line
 - 2. WTC expressed concerns over the National Grid interconnection permit ad study queue. SED will review and respond
 - h. Video taping was completed. Air time on local cable to be determined.
- 3. The meeting hand-outs included a description of the Northborough proposed project and the Cape wind project. Summary: Northborough project is local included in the state's net metering program and designed to offset municipal energy costs, while the Cape Wind project is a utility grade for profit enterprise offshore.

- 4. The Wind Turbine technical information binder will continue to be routed through the group. All reviewers agreed the tech data was helpful. R. Kane currently has the binder for review.
- 5. There are two meetings scheduled for next week:
 - a. State Senator Chandler and her staff to review the Dept of Agriculture APR situation and the 1% net metering program limitation
 - b. A briefing for the Northborough Department Heads
- 6. Bill O'Toole, Raj Melville volunteered to complete the 501C application for "Friends of the Wind Turbine" and establish the non-profit corporation.
- 7. M. Harling reported WTC table space for the fall Applefest celebration was purchased. Funds are need for brochures etc.
- 8. R. Jones is working on the Town Electric bill summary August completion of Algonquin bill review, followed by a meeting with the Town Engineer and Asst Administrator.
- 9. A Met Tower ribbon cutting ceremony was discussed at length and a tentative date of Thursday August 5 at 2PM set. Volunteers will be needed to assist with the set-up, program, parking, clean-up etc. Mo Tougas will be advised as plans firm-up.
- 10. F. Litchfield presented a new potential location for the turbine all Ball Hill road in the vicinity of the Tougas property. Further investigation is underway.
