# Norwell Board of Selectmen Meeting Minutes January 18, 2012

John Mariano opened the meeting and introduced Gregg McBride and Ellen Allen. Not Present Town Administrator James Boudreau.

## **CITIZEN COMMENTS - None**

- 7:35 Chief Reardon Fire Department Budget Chief Readon went through his budget and explained various line items including the staffing model, recall procedures, and a financial comparison of additional staff vs. additional overtime. Increases are requested for vehicle repair and maintenance and building maintenance at the Central Station. 51% of calls are for ambulance service. There is new legislation proposed that could reduce insurance reimbursements for ambulance services. The Chief is requesting again this year a replacement for the 2004 Command Vehicle (w/180,000 miles) in the capital budget.
- 8:00 Recreation Commission Little League Field Dedication to Paul Crowley Present: Ginny Maree, Pat Richardson, Denise Nestor and Joanne Collins. Chair Ginny Maree explained that the Recreation Commission had been approached by Paul Crowley's sister-in-law Joanne Collins with a request to have Little League Field #3 dedicated to Paul to recognize over 20 years of dedication to the youth sports in Norwell. MOTION: Gregg McBride moved that the Board approved the request to dedicate Little League Field #3 at Woodworth Park to Paul C. Crowley. Seconded by Ellen Allen and unanimously voted.
- **8:15** Chief Ross Police Department Budget Chief Ross presented an on overview of services that the Police Department provides. Chief Ross highlighted the patrol staffing, cases that the Detectives have worked on, the role of the Prosecutor, Specialized Programs provided by the Department, detailed information on the department's fleet of vehicles and a survey comparison to other Towns.
- **8:45** Ron Mott Harbormaster Budget Ron Mott explained that the Harbormaster has limited powers and would like to be able to write citations. The Board will hold off on these discussions. Ron Mott then explained his budget.
- **9:00 Wendy Bawabe Historical Commission** Wendy Bawabe has requested that the Board of Selectmen decrease the membership size from 7 members to 5 members. The MGL states that the membership can carry between 3-7 members. *MOTION: Gregg McBride moved that the board change the membership of the Historical Commission from 7 to 5. Seconded by Ellen Allen and unanimously voted.*
