7:45 James Daylor of AmeresCo. – MAPC Energy Services – James Daylor of AmeresCo. made a presentation about a possible Energy Services Contract with the Town. AmeresCo would perform an audit of energy services throughout the town in order to identify cost savings opportunities. Systems examined would include heating systems, cooling systems, lighting, ventilation, windows, etc. at all town facilities. AmeresCo would make recommendations for changes and guarantee that energy savings would more than offset the cost of system upgrades. If the Town decided to proceed with the proposal, it would issue a bond to pay for the upgrades and the energy savings would cover the cost of servicing the debt. If for any reason AmeresCo's guaranteed savings did not materialize, the company would reimburse the town. Ellen Allen inquired about AmeresCo's financial profile and past experience making payments under its guarantee. Daylor said they had never had to make a payment. Jim Boudreau explained that the MAPC (Metropolitan Area Planning Council) had performed the bid process on behalf of all its member communities and selected AmeresCo as the best provider of this service.
