MOTION: Ellen Allen moved that the Board approve the agreement between the Town of Norwell and the James Library. Seconded by David DeCoste and unanimously voted. Gregg McBride and David DeCoste signed the Agreement and Ellen Allen will sign with the Town Clerk who will notarize it.

Town Administrator Jim Boudreau will be preparing and presenting the budget this year per the new Charter, rather than each department presenting its own. Gregg McBride asked to have the School Committee attend a Selectmen's meeting to get an update on the School Department budget.
