Chair Sam Demeritt opened the meeting at 7:05. Also present were Susan Mooney, Kristen Lamb, Cheryl Smith, Johan Kerkhove, alternate, and Terry Bonser, alternate. Raelene Shippee-Rice was being sworn in as a full member in the town clerk's office. Kerkhove was seated for Noel Carlson and Bonser was seated for Debra Kimball. Kimball arrived at 7:12 so Bonser was then seated for Shippee-Rice. Guests were Mark West, Wetlands Scientist, Frederick Fernald, Helen Fernald, landowners in Nottingham, their son Alex Fernald and Tom Howe, representing The Forest Society (SPNHF).

Minimum Expedited Permit: Mr. West, representing property owner Laurie Weisz, was looking for Commission approval to dredge a pond that was constructed years ago but has filled in with silt and organic material and wetland plants such as cattails. The property is identified as Map 46, Lot 10 and is a 100acre property on Stevens Hill Road. Most of the property is conserved under the Wetlands Reserve Program through NRCS. The residence and barn are not included in the conservation easement. Of the 100 conserved acres, there are 16 acres of wetland including a 14-acre black gum swamp. The aforementioned pond is 18,000 ft<sup>2</sup> and it is presently 12 feet deep. It was constructed in an upland area above a natural spring and over time has filled in. Mr. West indicated that the project would be done in August when it is driest, the pond will be dredged to historical depth, the cattails and other littoral plants will be removed and a steep slope will be constructed to discourage natural reseeding of the emergent plants. The area will be seeded and stabilized with native flora. Additionally, invasive species of plants will be removed from the adjacent field. Kerkhove expressed concern for where the dredge material and plant waste "spoils" will be placed. West said they would be put into a lower area of upland. Blandings turtle, a protected NH specie, and painted turtles have been noted in the area. Lamb was not in favor of disturbing the site where Blandings eggs might be incubating; there followed a discussion about postponing the project to a later date, and activities of other wetland species in the summer and fall. It was decided that West would inspect the area prior to dredging activities to determine if there are any turtle nests at the site. If so, then the equipment will be directed away from those areas.

A motion was made by Mooney and seconded by Kimball to approve the Minimum Expedited Permit contingent upon Mr. West's prior inspection of the site to determine if any Blandings turtle nests are located there. All seven votes were in the affirmative.

Mr. West thanked the Commission and left at 7:23. At the same time Shippee-Rice arrived. Mr. Bonser volunteered to sit down.

**Conservation Easement Project**: The Fernald party and Tom Howe were at the meeting to discuss a 95.5 acre conservation easement identified as Map 52, Lot 4-

1. This easement had been previously been discussed in non-public sessions as per RSA 91-A:3 and was known to the public only as P1 and the amount of funding that had been directed from the Conservation Fund toward this project.

Mr. Howe gave an overview of the project and process. Nottingham will be a funding partner and the Forest Society will be the primary interest holder of the conservation easement deed. Helen Fernald will remain as the trustee of the trust that owns the fee interest (the family trust will still own and manage the land). The property has 960 feet of frontage on Pawtuckaway Lake, 1827 feet of frontage on Deerfield Road and abuts the State Park along the west boundary. The property is described as "well managed forest land ... (including) perched wetlands with frontage on Mile Brook containing a few black gum trees". The Natural Heritage Bureau has estimated that these trees with a 20" DBH could be 300 years old. The NH Wildlife Action Plan gives the property "a high score". The Fernald Family accepted \$250,000 from the Conservation Commission toward the conservation easement. In February 2013, the appraised full value of the conservation easement was valued to be between \$550,000 and \$560,000. The Fernald Family is gifting the remaining \$300,000 to \$310,000 of the appraised easement value. The Forest Society will be responsible for the administrative costs of the project. The Executory Interest of the easement will be given to the Town of Nottingham. The Forest Society will monitor the property annually to insure that activities on the property are in compliance with the conservation easement. There will be no house lots on the easement. There will be guaranteed public access. Owner discretion will or will not provide a parking area, allow snowmobiles, hunting and fishing. At the present time hunting and fishing is permitted.

Mr. Howe next discussed the time line for moving the project forward. It was tentatively agreed to hold the Public Hearing, as per RSA 36-A:5 I & II. The Board of Selectmen (BOS) will need sufficient time to review the easement deed and other legal documents associated with the project and one or two preliminary meetings with the BOS should be scheduled prior to the Public Hearing. Demeritt will communicate with the BOS about a meeting schedule dependent upon Mr. Howe's own schedule and that of the Fernalds' Mr. Howe will send a fact sheet on the project to Demeritt for public distribution.

The Fernald party and Mr. Howe left the meeting at 8:08.

**VRAP River Water testing**: The testing of river water quality at two sites on the North River and from one site on Little River is problem free so far and on schedule. Bonser and Kerkhove were invited to join a testing session to become familiar with the equipment and procedures.

It was moved by Lamb and seconded by Kimball to adjourn. All seven votes were in favor. The meeting was adjourned at 9:15.
