Mrs. Bonser noted that the Appendix document is directly opposed to the document she found from NHMA.

The Board members discussed that NHMA has not been updated since 2010.

Mr. Chairman noted that the <u>By-Laws and Rules of Procedure</u> definitely need to be updated due to RSA changes. He also raised the question he read in the *New Hampshire Town and City, July/August 2007* issue: What if an application or appeal is continued during several meetings? Does the same mix of regular and alternate members have to participate in each of those meetings?

Mr. Davies suggested a separate labeled table for the non-seated alternates. He went on to say that having been an alternate for quite some time he feels much more involved sitting with the Board than with the public.

The Board welcomed Mr. Davies suggestion.

Mr. Colby reminded the Board that there would be no other microphones but the seating arrangement could be accommodated with a little shifting.

Mr. Chairman said we can address changing the By-Laws after further counsel.

# Review Draft 2 of the Steep Slope Protection District

Mr. Colby informed the Board of the reply from the Fire Department regarding the driveway slopes to allow the Fire Department access to a home in an emergency should be no greater than 12%.

Mr. Colby also informed the Board that the Wireless Communications Ordinance did indeed pass. The Board agreed to re-enter that line in the Steep Slope Ordinance. There were several other Articles that passed at a prior election that had not been added to the updated Zoning Ordinance, those Articles will be added to the Zoning Ordinance as time allows in the office.

Board members discussed their differing views of why this ordinance is important for the town. Some member's referenced areas in Nottingham with steep slopes and the issues being seen in those areas being seen in those areas such as erosion

Mr. Anderson asked if the Ordinance would supersede action by Shoreline Protection.

-Shoreline Protection would trump the Town's Ordinance.

Mrs. Bonser spoke regarding the Board of Selectman's concerns:

- What does this actually cover?
- o Inside the State Park is not our business
- o Shore Land Protection is covering most with the State regulations
- The Board of Selectman feel this Ordinance is a poor use of the Tax payer's funds due to the impact being questionable.

Mrs. Bonser stated that when you have to get an engineer involved you are pricing people out of what they want to do on their land.

Mrs. Mooney presented a Rise and Run print out that she created to aid Board members in visualizing the slopes when given percentages.
