Two letters of credit being held by the Town will expire on February 15 14, 2011. Mr. Brown explained that the process for calling letters of credit is very specific and 16 must be executed properly. Even if there is a chance the letters will be extended by the filing of 17 an amendment to the original Letters of credit, the town must still be prepared with all 18 documentation that is required to be delivered to the bank before the stated expiration date. The 19 Selectmen reviewed the documents and took the following action. 20 21 **Motion:** Bonser second Anderson to call the Gerrior Lane Trust letter of credit #20002462, 22 amendment #2 in the amount of \$24,133.44, and to authorize Selectman Peter M. Bock to sign 23 on behalf of the Nottingham Board of Selectmen, all documentation regarding this letter of 24 credit. Vote: 2-0 in favor. 25 26 **Motion:** Anderson second Bonser to call the Gerrior Lane Trust letter of credit #20002463, 27 amendment #2 in the amount of \$64,807.54, and to authorize Selectman Peter M. Bock to sign 28 on behalf of the Nottingham Board of Selectmen, all documentation regarding this letter of 29 credit. Vote: 2-0 in favor. 30 31 Bookkeeper, Marge Carlson asked the Selectmen to sign some checks before they leave today. 32 33 Mr. Brown informed the Board of a minor accident involving a Town vehicle on Tuesday, 34 January 25, 2011. 35 36 Ms Bonser gave the Board a handout and asked if the Board would consider a proposed 37 ordinance addressing written notification of and permission by landowners before entering 38 private property, be placed on the 2011 warrant. The Board agreed to have the Town 39 Administrator ask counsel to provide an opinion as to the validity of such an ordinance and if a 40 public hearing would be required. 41 42 Mr. Brown informed the Board of a grant award of \$5,000.00 from New Hampshire the 43 Beautiful as a reimbursement if the proposed equipment is purchased for the Recycling Center. 44 45 Mr. Brown asked the Board to review an inclement weather policy. There have been many 46 questions this year in regard to snow days and closings of town departments or facilities. In the 47 absence of an existing policy, this policy should address most questions. 48 **Motion:** Anderson second Bonser to approve the proposed policy as written. 49 **Vote:** 2-0 in favor.
