Lyn Seaward, Ezra Road, asked if door to door salesmen need permits to sell. The Commission informed her that yes they do.

Susan Cook-Seafood Co Op, Gary Avenue, would like for the Commission to appoint herself and four others to the Waterfronts Committee, with the Seafood Co Op counted as a member as well. Commissioner Gibson stated he did not feel that the Co Op could be a member. The Mayor tabled the item until the City Attorney could advise the Commission on this matter.

Montye Beamer, City Planner, stated that Ordinance 2000-09 needed to be corrected before the Co Op or the Waterfronts Committee could use it for points for grants.

Donia Dewees, stated she would like to have the property at the corner of Lagoon Avenue and US Highway 1, restored to the original appearance and the commercial zoning retracted. What does she need to do to get that done?

There was discussion of the history and purpose of the County ditch and the Stop Work order from County and City for the property at Lagoon Avenue and US Highway 1.

The Commission informed those concerned that as the development of this property proceeds there will public meetings on the matter for them to voice their concerns.

Mayor Mary Lee Cook passed the gavel to the Vice Mayor, and spoke as a citizen. She wanted to express her satisfaction with the Volusia County Sheriff's Department and cited an incident at her home which was handled professionally and quickly. She thanked the Captain for a job well done.

Montye Beamer, City Planner stated the amendment to the Interlocal Agreement-Annexations had passed the County Council 6-1.

AN ORDINANCE OF THE CITY OF OAK HILL, VOLUSIA COUNTY, FLORIDA REPEALING SECTION 26-21 (PURPOSE; ADOPTION OF COUNTY ORDINANCE) AND SECTION 26-22 (DISCHARGE OF FIREARMS WITHIN THE CITY PROHIBITED) TO BE IN COMPLIANCE WITH STATE LAW PREEMPTING THE REGULATION OF FIREARMS; PROVIDING FOR SEVERABILITY, AND PROVIDING FOR AN EFFECTIVE DATE.
